- 1. - b. **MEDIATION**: Any disputes or differences, which are not settled amicably through conciliat ion, then either of the parties, may approach for mediation to settle under mediation Act, 2 023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended fro m time to time.
- c. **AMRCD**: Any disputes or differences between the parties are not settled amicably with co nciliation and/or Mediation, then such disputes or differences shall be resolved through Ad ministrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differe nces relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between C PSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
- d. **ARBITRATION**: Any disputes pr differences where clause no. (c) is not applicable, the part

ies may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provi ded the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with refer ence to the value of the dispute and not the value of the contract which may be much high er. In all other cases, arbitration shall not be a method of dispute resolution arising out of this contract.

e. **JURISDICTION**: If the matter is not resolved through above means, the dispute shall be re solved in civil court of law at Jharkhand only.

Note:

- 1) Material is required to be supplied on FOR-destination basis duly unloaded & insured basis.
- 2) PUC certificate of Pollution Control, if applicable should be submitted along with the supply of materia ls.
