- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- c. **AMRCD**: Any disputes or differences between the parties are not settled amicably with co nciliation and/or Mediation, then such disputes or differences shall be resolved through Ad ministrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differe nces relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between C PSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
- d. **ARBITRATION**: Any disputes pr differences where clause no. (c) is not applicable, the part ies may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provi ded the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with refer ence to the value of the dispute and not the value of the contract which may be much high er. In all other cases, arbitration shall not be a method of dispute resolution arising out of t his contract.
- e. **JURISDICTION**: If the matter is not resolved through above means, the dispute shall be re solved in civil court of law at Iharkhand only.
