1. 5. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 8. #### 1. Scope of Supply

#### 2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 3. Buyer Added Bid Specific ATC

1) Earnest Money Deposit: Bidders who are not exempted for EMD as per GEM exemption rule, ha s to upload scanned copy of EMD document along with bid and hard copy of the same must be se nt within 05 days of bid end date to the following address:

8) **MEDIATION :**Any disputes or differences, which are not settled amicably through conciliation, then eith er of the parties, may approach for Mediation to settle under Mediation Act, 2023. The procedure is to be f ollowed as prescribed in the Mediation Act,2023 amended from time to time.

9) **AMRCD:** Any disputes or differences between the parties are not settled amicably with conciliation and/ or Mediation, then such disputes or differences shall be resolved through Administrative Mechanism for R esolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretation and applicatio n of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs)/Port Trusts , inter-se and also between CPSE(s) and Government Department(s) / Organization(s) shall be taken by eit her party for its resolution through AMRCD.

10) **ARBITRATION** :Any disputes or differences where clause no. iii is not applicable, the parties may go f or arbitration as per the provisions of Arbitration & Conciliation Act, 1996 provided the disputes is restricte d to less than Rs. 10 Cr. (Ten Crores). This amount is with reference to the **value of the dispute** and not the **value of the contract** which may be much higher. In all other cases, arbitration shall not be a metho d of dispute resolution arising out of this contract.

11) **JURISDICTION :** If the matter is not resolved through above means, the dispute shall be resolved in ci vil court of law at Jharkhand only.

12) Indenter shall intimate in writing within two week from the date of Gem Contract about site rea diness to the supplier for installation & commissioning of the required items.

13) Supply, installation & commissioning will be done within delivery schedule of Gem Contract (i. e before last date of completion of delivery) failing which LD will be applicable to supplier if reason of delay attributable to supplier.

ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.

iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

iv) The Seller becomes bankrupt or goes into liquidation.

v) The Seller makes a general assignment for the benefit of creditors.

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.
