SCOPE OF WORK

Deployment Of Manpower Semi-skilled – 04 No's and Un-skilled-14 Nos. on working days, for Underground civil work at Jaduguda mines for below mentioned job:

- 1) Construction of RCC wall in level.
- 2) Construction of stowing wall, Ladder way, OT etc.
- 3) Maintenance of Road in Underground mine.
- 4) Civil Maintenance work of Vertical shaft.
- 5) Construction and Maintenance of Drain, Manhole etc.
- 6) White washing and painting work in the Underground mine.
- 7) Any other work related to civil in underground of Jaduguda mine as per the direction of EIC.

Terms & Conditions:

- 4. The total amount of security deposit will be 10% of the awarded value of work i.e. contract price. Fifty percent of this amount (i.e 5% of the contract price) shall have to be deposited as initial security deposit SD in the form of demand draft/ bankers cheque/ BG during execution of agreement or commencement of work at site whichever is earlier. Balance 5% shall be recovered from the R.A. Bills till the full amount of security deposit is recovered.

- 8. Escalation: No extra payment will be made in any circumstances for this work except the quoted amount including GST.
- 9. The TDS on GST shall be recovered from the bill if applicable.
- 10. Deployed manpower should be well behaved.

- 14. In case of stoppage of work by local people/Bandh or any other reasons, no idle charges will be paid by corporation towards Labour, Plant and Machinery etc. to the contractor for this work

- 15. Working hours: The work shall normally be carried out from 7.00am to 12.00pm and 2.00 pm to 5.00 pm on all working days.
