2) Bidder shall have successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

a) Three(3) similar completed works costing not less than the amount equal to 40% (14.78 lakhs) of the estimated cost

2. Removing of Spillage slurry from running drain after removing the drain Cover.
 3. Dry slurry loading into the tractor trolley, measurement of individual trolley by UCIL, then transporting and unloading at the Duping yard No.-4/ paddock area or ground hopper or any other location as per instruction of EIC and refixing the drain cover in proper way in the last.
 4. Medical and Height pass from UCIL Safety department of all workers engaged in height work more than 1.5 Meter is a must requirement and without this work cannot be started.
 5. All temporary work for execution of the work like construction of go down, temporary road etc, No separate payment will be paid for this work.
 6. Any equipment, material or services which are not mentioned in the Bid document but required for completion of the work in safe and efficient manner shall be deemed to be included.
 7. Maintenance of service road for which no payment will be made.
- Note:-Contractors are advised to see the area to get acquainted with the actual features of the land where work is to be executed and get other related information before quoting their rates for carrying out the work successfully.

TECHNICAL SPECIFICATION

All work for civil item shall be carried out as per latest relevant Indian standards, CPWD/ISI and MORTH specification which shall form part of this specification and instruction of the Engineer in Charge in case of conflict or where an aspect of work is not covered by the Indian Standard and specification, EIC instruction shall be strictly followed.

6. Penalty-

7) Labour escalation: Labour escalation will be paid in this contract as per given formula. The Labour wage escalation will be paid taking labour component @30% as per formula mentioned below up to the scheduled completion date including duly approved Time Extension, if any, on the items mentioned in the schedule of the items and rates. No escalation will be attracted for the period beyond duly approved time extension.
