1. Vehicle:

As per specifications given here under "Water Tanker Truck" means contract carriage of a Heavy capacity commercial motor vehicle MS water tanker with 9000 litre fitted with necessary fittings and accessories, along with valid registration, permit and insurance document and driver with driving license. The Heavy capacity commercial motor vehicle MS water tanker with 9000 litre must be Gross vehicle weight (GVW= 16200 Kg, Length of chassis = 6970mm, Width of chassis = 2434 mm & Height of chassis = 2550 mm & the axle configuration (no. of outside tyre x no. Of driving tyre) = 4 x 2.

1.2 Minimum Manpower & Equipment to be deployed by the contractor:

The contractor will be required to deploy minimum manpower to carry out the work as mentioned below:

1.3 In case for fulfilment of scope of work, more number of manpower is required, then same will be deployed by the contractor at no extra cost.

1.4 UCIL is intending to sprinkle water to suppress the dust on haul roads, other places & supplying drinking water at Musabani MURP colony from Bagjata Uranium Mine and The scope of work under this contract will consist and comprise of the following:-

A. Providing on hire water tanker of 9000 litre capacity with water sprinkler for water sprinkling departmental roads & public road, office buildings & staff quarters, Parking places of trucks / troll as other road to village approach roads, plantation site for watering to the plants, sprinkling water on mines approach / access roads & any other related places at uranium mines.

B. Transportation of water for sprinkling as well for drinking purpose from the source to places as mentioned above, water sprinkling / water to plant on all working days at specified timing as given by concerned Mine Manager.

C. The contractor has to engage valid HT license holder, competent, disciplined & physically fit drivers on water tanker, the driver will always keep driving license with him while on duty & will provide the same on demand by Mine Manager/ authorized officer.

D. The contractor will ensure that the water is to be always maintained in good condition & should be deployed in clean & tidy condition with proper housekeeping.

E. The time schedule as indicated is tentative & the company in its sole discretion reserve the right to alter the same without giving any notice.

1.5 Vehicle (s) to be provided with all other major components/ accessories, safety gear, good seats, glass es, tyres & stepney etc. The vehicle should be in excellent condition.

1.6 UCIL has the right to inspect the vehicle(s) in details before any further processing and if the quality is not good, the vehicle would be rejected without assigning any reason whatsoever, such vehicle(s) has to be discounted and replaced by similar or better specifications vehicle(s) till the end of the contact period or extended period. UCIL is the sole authority to decide on the quality of the vehicle.

1.7 The vehicle deployed must have necessary valid Taxi/ relevant permit for movement in states/ area of operation as specified above. In case, duties may require movement of vehicle(s) outside from specified states/ area of operation, the contractor has to provide necessary permits for which UCIL will reimburse the amount paid to the appropriate authorities on this account against submission of documentary proof.

1.8 The award of contract(s) to the contractor(s) will not entitle him exclusive right to supply the entire requirement of hired vehicles. UCIL reserves the right to use its own vehicle (s) and equipment at its own convenience and direction for the works during the currency of the Contract.

1.9 Vehicle(s) deployed should be duly registered with R.T.O. under valid permit(s), all taxes paid comprehensively insured covering the risk of all passengers travelling in the vehicles. Vehicles should have valid permit(s), required tools, spare wheels, portable fire extinguisher and spare for repairs to be carried out en-route.

1.10 The contractor will ensure that vehicle(s) are kept clean and upholstery with neat seat covers duly washed/ dry-cleaned to be providing at an interval as specified by the Engineer-in-charge.

1.11 The contractor will ensure that drivers of the vehicles are given "One (01) day's off in a week" and provide alternate drivers for the day.

1.12 The duties of the vehicles are 8 -10 hrs. Including Sunday and holidays. The monthly rent **includes** Sunday and holiday in a month.

1.13 There is no restriction on km run by the vehicle.

1.14 The vehicle can be parked outside main gate or inside plant premises (with prior permission) at designated place during night at the risk and cost of contractor.

Terms & Conditions for Model & year of manufacturing of Vehicle:-

1. The manufacturing year of the vehicle is **not earlier than 2018** as per scope of work for subjected vehicle package. The contractor will have to submit following documentary proof of ownership of the vehicle as given below.

- a) Submit documentary proof of ownership/ registration of the vehicle AFTER placement of work order AS PER DEPLOYMENT SCHEDULE.
- b) They should place the vehicle to the corporation AFTER placement of work order AS PER DEPLOYMENT SCHEDULE. In case of old vehicle UCIL has the right to inspect the vehicle in details before any further processing and if the quality is not good the same would be rejected without assigning any reason whatsoever. UCIL is the sole authority to decide on the quality of the vehicle.

If the contractor fails to fulfill the above two conditions the security deposit will be forfeited and the order will be cancelled. **Also liable to applicable GST on forfeiting of Security deposit.**

The Pre- qualification criteria (PQC) to qualify in Techno commercial Part are as below:-

1. The Bidder must have **experience in similar nature of works in last seven years** ending last day of month previous to the one in which applications are invited should be either of the following:-
 - a) One similar nature of work not less than 80 % of the estimated value of the work .

 - b) Two similar nature of work not less than 50 % of the estimated value of the work .
Or
 - c) Three similar nature of work not less than 40 % of the estimated value of the work .
2. Average Annual financial turnover during the last 03 (Three) consecutive financial years, ending 31/03/2023 shall be at least 30% of the estimated cost supported by the audited annual accounts of each year.

The Bidder shall furnish a copy of **MSME/NSIC, ESIC, GST, PF Registration Number**

er and Make in India (MII) certificate.

Bidder must submit **Work Order and Work done or Work Completion Certificate** mentioned executed amount and date of completion.

Similar Works means: - "Experience in execution of work with any Central/ State Govt. Organization / PSU/ Public Listed Company for Hiring of Vehicle/ Hiring of Water Tanker."

Geological Presence:-

The bidder participating in the bid must have the Head Office or a Branch Office in the East Singhbhum district in the State of Jharkhand.

Documentary evidence issued by Government of India or Government of Jharkhand to prove establishment of office in East Singhbhum District of Jharkhand State is given below:-

- A) Trade License issued by Govt. Authority of Jharkhand etc , or
- B) GSTIN registration, or
- C) Udyam /MSME /Udyog Aadhaar certificate.

Failure to submit the above documents for the office address at East Singhbhum, the bidder will be disqualified from the Techno Commercial bid.

Relaxation of conditions of prior turnover :

Pre-qualification criteria with respect to Prior Turnover may relax for Start-ups [Whether Micro & Small Enterprises or Otherwise] as per GOI guidelines subject to meeting of Quality and Technical specifications. UCIL may consider allowing the participation of "Start up" companies with capability to execute the **supply/ services**, as per technical specifications/ perform the job as per scope of work specified in the tender and subject to meeting extant & relevant guidelines of Government of India. This should be confirmed and substantiated in the technical bid. **The bidder who intends to participate as "Start-up" company should enclose the Certificate of Recognition issued by Department of Industrial Policy and Promotion, Ministry of Commerce & Industry, Govt. of India during submission of Technical bid.** (AS DEFINED IN GAZETTE NOTIFICATION NO. Note: - The bidders seeking relaxation for prior turnover must enclose the certificate over the relevant criteria as mentioned in PQC of the bid, otherwise the bidder will not be considered for exemption.
