 - a) Three similar completed each works costing not less than the amount equal to **Rs. 5.01 Lakhs** or
 - b) Two similar completed each works costing not less than the amount equal to **Rs. 6.26 Lakhs** or
 - c) One similar completed work costing not less than the amount equal to **Rs. 10.03 Lakhs.**

Bidder should submit their supporting documents like NSIC Registration certificate, MSE registration certificate issued by competent Govt bodies to become eligible for the above exemption. Also NSIC/MSME certificate uploaded by bidders shall cover the item tendered to get EMD/Tender fee exemption.
