The Tenderer who wish to participate in the Tender shall fulfill the following Qualifying Criteria.

A. Experience Criteria

The bidder shall have experience of successfully completed similar works during last 7 years ending on 31.07.2019 should be either of the following (a or b or c) :

- a) one similar completed work costing not less than Rs 5,13,160/-, or
- b) two similar completed works costing not less than Rs 3,20,725/- each, or
- c) three similar completed works costing not less than Rs 2,56,580/- each.

B. Financial Criteria

The Average Annual financial turnover during the last 3 years, ending on 31.03.2019 should be at least Rs 1,92,435/-.

Similar Work means execution of Rubber lining work or supply of MSRL Tank/Vessel.

UCIL will only provide water and electricity at free of cost. Party shall engage required manpower, Rubber lining Raw Materials, Tools and Tackles (including Blasting equipments, Air Compressor, Boiler, scaffoldings), Supervisor and all other consumables if required.

The bidder shall submit documentary evidence by way of copies of work order, completion certificate, audited balance sheet including profit and loss account, necessary undertaking etc. along with bid, failing which

tenderer will be disqualified.
