 - Three Similar completed works costing not less than an amount equal to Rs. 1,26,166 /-
or
 - Two similar completed works costing not less than an amount equal to Rs. 1,57,707 /-
or
 - One similar completed work costing not less than an amount equal to Rs. 2,52,331 /-

Bidder shall furnish PAN, GST, MSME and PF Registration Number, IT returns of the last three financial years, Balance sheet and Profit and Loss statement of the last three financial years.

Similar type of works means carrying out "Testing of oil samples of transformer / calibration of electrical instruments at NABL accredited laboratory"


