The following terms & condition to be added in tender documents.

- A.** The eligibility is to be decided strictly based on documents submitted at the time of receipt of tenders. No additional documents are to be allowed to be submitted after receipt of tenders but there is no bar to seek clarification or authentication of submitted documents. However in case of poor response, with a view to increase the competition, admission of additional documents to meet the PQ – criteria may be allowed subject to the condition that
- 'Poor Response' implies when less than three bids are found suitable on the basis of submitted eligible documents as per NIT.
  - The additional document should not be issued subsequent to last date of receipt of tender as mentioned in the NIT.
  - The bidder submitting additional documents has submitted EMD and tender cost as prescribed in NIT.

The opportunity of submission of additional documents will be given to all the bidders.

- B.** To qualify for entitlement as SC/ST owned MSME, the SC/ST certificate issued by District Authority in addition to certificate of registration as per guidelines of GOI shall be furnish by bidder.
- C.** Pre-qualification criteria with respect to Prior Turnover and Prior experience may be relaxed for Micro & Small Enterprises as per GOI guidelines subject to meeting of Quality and Technical specifications, UCIL may consider allowing the participation of "Start up" companies with capability to execute the supply/ services, as per technical specifications/ perform the job as per scope of work specified in the tender and subject to meeting extant & relevant guidelines of Government of India. This should be confirmed and substantiated in the technical bid.
- D.** The bidder who intends to participate as "Start-up" company should enclose the Certificate of Recognition issued by Department of Industrial Policy and Promotion, Ministry of Commerce & Industry, Govt. of India during submission of Technical bid.

- E. The purchase preference to MSME is not applicable for works contracts where supply of goods not produced by MSMEs is also involved.
