Sealed quotation(s) are/is invited as per the price bid format attached alongside for the above mentioned job. Sealed quotation(s) may be reached to the office of undersigned on or before 24/03/2025 upto 3:00 PM. The bids shall be opened on 24/03/2025 at 3:30 PM.

**Special Terms and Conditions**

- (1) **Completion Time**: - Complete rewinding fitting & Testing of 37 Nos. LT Burnt motors as per schedule of items shall be rewinded within 90 working days from the date of commencement of work.
- 2) **Security Money Deposit**:- Security Deposit equivalent to 10% of the ordered value is required to be deposited under this contract. In which, the initial security deposit equivalent to 5 % of the ordered value is required to be deposited in Accounts Department – UCIL in the form of demand draft before the start of the work. In addition to the above, further balance security deposit will be deducted from the running account bills @ 10 % of the gross value of every R.A. bill till the full amount of security deposit equivalent to 5 % of the ordered value is recovered by the corporation. 100% security deposit will be refunded on written request in duplicate to the Engineer-in-Charge after satisfactory completion of defect liability period of 06 months.
- 3) **Rate**: - Rate of the individual LT motor shall be furnished with supply of New SEC Wire (as per I:S 13730 Grade-2/ part –III) as required for individual motors inclusive manpower after deducting the scrap copper value (as retained to the contractor). The rate quoted by the contractor shall be firm. No escalation will be entertained after quoted the price.
- 4) **Defect Liability Period** :- A defect liability period of 06 (Six) months from date of handed over of repaired motor at site. Further, the contractor will be responsible for rectifying the defect at his own cost if motor will be found any defect within the defect liability period.
- 5) **Details Supply of Materials**:- Only SEC Wire required for motors will be supplied by contractor and other materials such as insulating Materials, Bearings, Lead Wire, Terminal Socket and insulating varnish etc. are to be supplied by UCIL in free of cost.

- 6) **Tools & Tackles**:- Only EOT Crane & Oven for heating the motors after varnishing shall be provided by UCIL and other tools & tackles required for the work shall be provided by contractor.
- 7) **PPE**:- Safety Goggles, Safety Gloves and PPF are to be provided by contractor while working at the site for the minimum manpower-(01 Skilled,02 Semiskilled and 02 Unskilled) per day during the contract period.
- 8) **Bill**:- One RA & one final bill shall be paid after submitting by contractor in triplicate.
- 9) **Penalty**:-
  - I. Failure in no load testing of motors shall be rectified by contractor at his own cost before handover the motor.
  - II. If the defective motors are not completed within the completion period then ½ (Half) % per week will be levied and maximum up to 5 (Five) % of the contract value for a delay up to ten weeks from the end date of contract period. The order will be cancelled if the party fails to start the work even after 2(Two) weeks from receipt of work order.

#### **SCOPE OF WORK**

- 1) (i) The job shall be carried out at R & M Shop (E) as per instruction of Engineer In Charge/ Engineer representative in basis of the priority/ demand of plant operation.  
  
(ii) SEC Wire supplied by contractor shall be entered in CISF main gate with challan after prior Permission of Engineer-in-charge and the scrap copper wire shall be retained by contractor after measurement and taken out through material gate pass signed by competent authority.  
  
(iii) Separate attendance register and work done register shall be maintained by maintained by contractor during the contract period.
