- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. - 5. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local

content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. - 8. - 9. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 % of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

3. Certificates

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
- 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

9. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

10. Inspection

1) **Guarantee/Warranty:** The Tyre should be guaranteed / warranted for the period of 01 Year from the date of receipt and acceptance of material at our store or 300 operational running hour from the date of fitment within 12 months from the receipt and acceptance of material whichever is earlier against manufact

uring defects excluding abnormal failure, such as operation / maintenance fault s / condition such as presence of water, side cuts, piercing by material other than the mine ore /waste.

2) **Pro-rata Penalty:** In case the life obtained of the tyres is less than the guaran teed life as mentioned , a penalty amount will be deducted on pro-rata basis. Pro-rata penalty will be calculated as per formula

(B/A)xC Where.

A = Life of the tyre i.e 300 operational running hours

B = Remaining life of tyre at the time of failure

C= Cost of the tyre

- 3) **Related party clause**: Subsequent to bid opening, if it is found that bids sub mitted by related parties in which there seems to be collusion are liable to be re jected. Parties are considered to be related if one party has ability to control th e other party or exercise significant influence over the other party in making fin ancial and / or operating decision.
- 4) Dispute resolution Mechanism and Jurisdiction:
 - a. **Conciliation**: Notwithstanding anything contained in this contract, any disputes or differences whatsoever, which are to be settled ami cably between the parties with their authorized representative, shall be resolved through conciliation.
 - b. **Mediation**: Any disputes or differences, which are not settled ami cably through conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended fr om time to time.
 - c. **AMRCD**: Any disputes or differences between the parties are not s ettled amicably with conciliation and/or Mediation, then such disput es or differences shall be resolved through Administrative Mechanis m for Resolution of CPSEs Disputes (AMRCD). Any disputes or differ ences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Govern ment Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
 - d. **ARBITRATION**: Any disputes or differences where clause no. (c) is not applicable, the parties may go for arbitration as per the provisio ns of Arbitration & conciliation Act, 1996 provided the disputes is re stricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the value of the dispute and not the value of the contract which may be much higher. In all other cases, arbitration shall not be a method of dispute resolution arising out of this contract.
 - e. **Jurisdiction**: If the matter is not resolved through above means, t he dispute shall be resolved in civil court of law at Jharkhand only.
