1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications.  - a. **Conciliation**: Notwithstanding anything contained in this contract, any disputes or differences whatsoever, which are to be settled amicably between the parties with t heir authorized representative, shall be resolved through conciliation.
 - b. **Mediation**: Any disputes or differences, which are not settled amicably through con ciliation, then either of the parties, may approach for mediation to settle under med iation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.

- c. **AMRCD**: Any disputes or differences between the parties are not settled amicably with conciliation and/or Mediation, then such disputes or differences shall be resolv ed through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD). A ny disputes or differences relating to interpretation and application of the provision s of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Por t Trusts, inter-se and also between CPSE(s) and Government Department(s) / Organ ization(s) shall be taken by either party for its resolution through AMRCD.
- d. **ARBITRATION**: Any disputes or differences where clause no. This amount is with reference to the value of the dispute and not the value of the contra ct which may be much higher. - e. **Jurisdiction**: If the matter is not resolved through above means, the dispute shall b e resolved in civil court of law at Jharkhand only.
