#### U.C.I.L EMPLOYEES MEDICAL ATTENDANCE RULES

#### **Short Title and Extent of Application**

- 1. These rules may be called UCIL Employees Medical Attendance Rules and will be given effect from the date of notification.
- 2. These rules shall apply to :
  - i) all regular employees of the company including their dependent family members;
  - ii) all employees on contract employment with the company including their dependent family members;
  - iii) all superannuated employees of the company including their dependent family members to the extent medical facilities available at UCIL Hospital.
    - (a) All dependents of deceased employees of the company to the extent of medical facilities available at UCIL Hospital.
       (ADDED 2 (iii)(a) VIDE AI NO.UCIL/627 DATED 07.10.2002 )
  - iv) all trainees viz, Management Trainees, Graduate Operational Trainees, Apprentices including Probationers;
  - v) any such personnel otherwise specifically allowed by the company to avail the medical facilities from the company;
  - vi) all employees of Atomic Energy Central Schools and Central Industrial Security Forces located in company's different units including their dependent family members.

#### 3. **DEFINITIONS**

**Company** Company means Uranium Corporation of India Limited.

i) Medical Attendance and Treatment

Medical Attendance and treatment mean free of charge attendance and treatment at UCIL Hospital/(s), Company's recognised hospitals on referral

by UCIL hospital either at the Out-patient Department and/or at the Indoor company's Department and also includes own Pathological, Bacteriological, Radiological Clinics and company's recognised Pathological, Bacteriological, Radiological Clinics located at Jamshedpur City.

#### ii) Patient

Patient means a company's employees, his/her dependent family members and also includes superannuated employee of the company with spouse and dependent children, Management Trainees, Graduate Operational Trainees, Apprentices, probationers and Casual workmen etc. to whom these rules apply and who has fallen ill.

#### iii) Hospitals

Hospitals for the purpose of these rules means:-

- (a) UCIL Hospitals
- (b) Hospitals recognised by the company for specialised medical attendance and treatment in respect of patient on referral by UCIL Hospital to recognised hospitals of company located at Jamshedpur City; and other than Jamshedpur City.

A list of such recognised hospitals at Jamshedpur and various other places is enclosed as at Annexure-'A'

#### iv) Pathological, Bacteriological & Radiological Clinics

Pathological, Bacteriological, Radiological Clinics for the purpose of these rules means:-

- (a) Pathological, Bacteriological, Radiological clinics attached with the UCIL Hospitals.
- (b) Pathological, Bacteriological, Radiological Clinics etc. at Jamshedpur City duly recognised by the company for the purpose of investigation etc.

A list of such Laboratories and Clinics recognised by the company is enclosed as at Annexure-'B'.

#### (v) Family

Family for the purpose of these rules means:

- (a) husband/wife
- (b) parents but not Step-parents.

  In case of adoption, only the adoptive not the real parents. If the adoptive father has more than one wife, the first wife.
- (c) A female employee has a choice to include either her parents or her parents-in-law. Such option exercise can be changed only once during her service.
- (d) Children includes a legally adopted children, step children and widowed daughter dependent to the employee subject to the condition that he/she starts earning or get married, whichever is earlier.

#### (vi) <u>Dependency</u>

Members of family (other than one spouse) of an employee whose income is less than Rs.9000/- per month are treated as dependents for the purpose of medical attendance. Members of family in case of receipt of pension, the original pension (before commutation) should be taken into account and Dearness Relief is not to be taken into account for the purpose of dependency. (Modified vide AI No.UCIL/928 Dated 13.12.2021).

#### (vii) When both husband and wife are employed.

a) The spouse employed in a State Government, Central Government, Defence, Railways or Corporation/Bodies financed partly/wholly by the Central/State Government, local bodies and private organisations, which provides medical services, may choose either the facilities under UCIL Employees Medical Attendance Rules or facilities provided by organisation in which spouse is employed.

b) Where both are UCIL employees, either of them may prefer claim for self and eligible members of their family, according to his/her entitlement.

In both the type of cases, a joint declaration is required to be furnished as to who will be preferring the medical claim.

In absence of joint declaration in the case coming under (b), the concession is to be availed of by the wife and family members according to the entitlement of husband.

#### (viii) Medical Officers

Medical Officers for the purpose of these rules mean Chief Medical Officer and includes other Medical Officers irrespective of their designation. However, Chief Medical Officer is the administrative head of company's hospitals.

#### (ix) Chief Executive

Chief Executive for the purpose of these rules means Chairman and Managing Director of the company and in his absence any other officer authorised on his behalf to perform his duties and responsibilities in the capacity of Chairman & Managing Director. Chairman & Managing Director will have the over all authority for the purpose of these rules

#### 4. Medical Concessions in General

#### **Medical Attendance & Treatment**

- i) An Employee and his/her dependent family members are eligible to free medical attendance and treatment both in Out patient Department as well as Indoor department of company's hospital.
- ii) As provided as at Rule-3 (iii) an employee and his/her dependent family members are entitled to receive free specialised medical attendance and treatment for their ailments from the company's recognised hospitals located at Jamshedpur City and various other places subject to the condition that the

patient is referred from UCIL hospital/(s). Such hospitals have been notified as at Annexure-'A' to these rules.

#### **Investigations**

(i) An employee and his/her dependent family members are eligible to free Pathological, Radiological, Bacteriological, Ultrasound and Scan facilities to the extent available in UCIL Hospital and on referral from UCIL Hospital to such Centre/Clinics at Jamshedpur as notified as at Aannexure-'B' to these rules.

#### **Reimbursement:**

#### **Reimbursement of Diet Charges**

Employees in workmen category and their dependent family members during the course of their Indoor treatment are not required to pay diet charges either at UCIL Hospital and/or outside Hospitals recognised by the company. To maintain parity with the said category, diet charges during the course of treatment in respect of company's Officers & Supervisors including their dependent family members will not be levied.

#### **Reimbursement of cost of various Artificial Appliances:**

Reimbursement of the cost of various artificial appliances including the cost of Heart Pace Maker and replacement of the Pulse Generator, cost of replacement of diseased Heart Valves, Artificial Electronic Larynx, Artificial is permissible subject to the conditions that;

- (i) such instrument/equipment is prescribed by the specialist of the Hospital/(s) recognised by the company.
- (ii) company would make the payment direct to the supplying agency and not to the employee and/or his/her dependent family members concerned.

#### Reimbursement of expenses on purchases/replacement/ repair/ Adjustment of Hearing Aid:-

Company will reimburse the cost of Hearing Aid to company's employees and their family members on the basis of recommendation of ENT Specialist and Chief Medical Officer of the company and a maximum ceiling rate upto Rs.10,000/- for body worn/packet/behind the ear type/in the canal type (conventional) as per the requirement of the patient for one sided Hearing Aid. Any patient requiring a bilateral Hearing Aid on the basis of his/her hearing loss, may be permitted upto a maximum ceiling of Rs.20,000/-.

#### **Source of Purchase**

Quotations as per the specifications of the ENT Specialist can be had by the employee and/or by the patient from the Agencies supplying such instrument and the cost of the Hearing Aid could be made by the company to the supplying agency only.

# Reimbursement of expenses for purchase/replacement/ repair/adjustment of Artificial Appliances:-

In case of disease like 'Polio, an appliance is fitted to a child which has to be readjusted or replaced periodically as the child grows or the affected part improves. In such cases company will reimburse of cost of Boot (shoe) prescribed in the case of patients only after 3 (three) years, for a maximum limit of 3 (three) times in respect of a patient. The reimbursement cost of artificial appliances shall be allowed when these are certified as essential by a Specialist in the concerned Specialty in the hospitals and these are purchased from the Re-habilitation Department of Medical College Hospitals/ Artificial Limbs Centre, Pune and such other centres & organisations recognised for the purpose.

However, this provision will not be applicable to the Artificial Appliances such as, Heart Pace Maker, replacement of its Pulse Generator and cost of replacement of deceased Heart Valves except otherwise provided herein before specifically.

#### Reimbursement of cost of Intra-Ocular Lens implantation charges

Company will reimburse the full cost of treatment including operation, bed charges and cost of normal Intra Ocular Lens (IOL) incurred while undergone implantation

of the same at Jamshedpur Eye Hospital, Jamshedpur or at Shankar Netralaya Chennai on referral by UCIL Hospital.

Besides the same, the patients may exercise their option to take treatment of the aforesaid disease in any private Hospital recognised by the Central Government subject to the following conditions:-

- (a) the patient will have to attend UCIL Hospital for his ailment and on referral, he/she will be required to attend Jamshedpur Eye Hospital, Jamshedpur;
- (b) the treatment at any private hospital will be dependent upon the diagnosis of Jamshedpur Eye Hospital, Jamshedpur;
- (c) the charges towards treatment including operation, bed charges for implantation and cost of IOL in any private recognised Hospital will be reimbursable subject to limit of total amount of Rs.6,000/-;
- (d) No TA/DA is payable in such cases.

### Reimbursement of the cost of Knee and Hip implants

The maximum ceiling for reimbursement of the cost of knee and hip implant in respect of employees and their dependent family members will be as under:-

Nature of Implantation Maximum Ceiling

(a) Knee implant : Rs.60,000/- plus Rs.5000/-

as the cost of Bone Cement.

(b) Hip implant : Rs.35,000/- plus Rs.5000/-

as the cost of Bone Cement.

The reimbursement of the cost of the implants is subject to fulfillment of the following conditions:-

(i) The beneficiary patient should have taken treatment in a Government/Private recognised hospital with prior permission and referral of the UCIL Hospital.

- (ii) The beneficiary patient should have purchased the implant on the recommendations of the Orthopaedic Specialist of the recognised hospital of the company and on the basis of the lowest of three quotations.
- (iii) The treating Orthopaedic Specialist of the recognised hospital will give a certificate in writing to the effect that the implant has been implanted successfully and is functioning satisfactorily.

#### **Reimbursement of cost of Medicines**

Medicines to the extent admissible will be reimbursable by the company provided that such medicines are prescribed by company's Medical Officers and/or by attending Medical officer of the hospitals recognised by the company.

# 5. Recognised Private Hospitals and approved rates for Coronary Bypass Surgery:-

Besides the hospital recognised by the company for treatment of all Cardiac cases, company has also recognised a few private hospitals for availing of specialized treatment of Coronary Bypass Surgery . However, patients will have the option of referral from UCIL Hospital to avail treatment in case of Coronary Bypass Surgery subject to the conditions:-

- (i) treatment should be availed at any recognised private hospitals for the Coronary Artery Bypass Grafting (CABG) cases;
- (ii) and reimbursement of expenses incurred from the said hospital shall be limited to the amount which would have been incurred at company's recognised B.M.Birla Heart Research Centre at Kolkata as per their entitlement.
- (iii) No TA/DA will be admissible.

A list of such recognised private hospitals for the purpose of Coronary Bypass Surgery is enclosed as at Annexure-'C'.

#### **Entitlement of Accommodation**

#### **UCILHospital**:

The entitled class of hospital accommodation

in respect of beneficiary patient of the company will be as under:

(i) Executives & Jr.Executives : Cabin

irrespective of their Basic Pay. (with attached bath)

General Ward (ii ) Employees in the workman cadre

holding the post of Asstt. Foreman/ Tradesman-E or equivalent & above

irrespective of their Basic pay.

(iii) Other categories of employees General Ward

in workmen cadre.

#### ( INSERTED 6 (ii) VIDE AI NO.UCIL/670 DATED 09.05.2006 )

However, considering the seriousness of the ailment employees in workmen cadre may be allotted cabin (with attached bath) subject to its availability and allotment by Chief Medical Officer, UCIL.

(with attached bath)

#### 7 **Outside Hospitals**

The entitled class of hospital accommodation in respect of outside hospitals in respect of beneficiary patient of the company upon referral by UC IL Hospital will be :-

(i) Executives irrespective of Cabin AC

> of their Basic Pay (with attached bath).

(ii) Junior Executives irrespective of General Ward

> their Basic Pay and employees on workmen cadre.

(iii) Employees irrespective of posts Observation Ward.

> either Executives or Jr. Executives or workmen required for observation.

(iv) Cases of special nature required VIP Cabin.

in exigency of treatment subject

to approval of the Competent Authority

In case of non-availability of entitled class of accommodation, patient may be admitted in the next higher class of accommodation subject to the condition that a non-availability Certificate of the entitled class of accommodation from the attending specialist is filed by the beneficiary patient.

#### 8. Treatment from Government Hospitals

An employee and/or his/her beneficiary shall be entitled to medical attendance and treatment free of charge –

- (a) If such Government Hospital at or near the place where he/she falls ill as can in the opinion of the Medical Officer of the Hospital concerned provide the necessary and suitable treatment; or
- (b) if there is no such hospital as is referred to in sub-clause (a) in such hospital other than a Government Hospital at or near the place as in the opinion of the Medical officer of the Hospital concerned, provide the necessary and suitable treatment.

Where an employee and dependent is entitled for free of charge, to treatment in hospital, any amount paid by him on account of such treatment shall, on production of a certificate in writing by the Medical Officer of the Hospital concerned in this behalf & Essential Certificate, be reimbursed to the extent permissible by the company.

#### 9. Escort/Attendant

If it is certified by CMO/MO, UCIL Hospital that it is unsafe for the patient owing to serious nature of ailment, to travel unattended and that an Escort/Attendant is necessary to accompany him/her to the place of treatment the patient and/or his beneficiary may avail the facility of an Escort.

#### 10. Travelling Allowance

(a) Employees and dependent family members are entitled to Travelling Allowance for their journey to obtain appropriate medical attendance and

treatment on referral by UCIL Hospital to company's recognised hospitals at Jamshedpur City and company's recognised Pathological, Radiological, Ultra Sound, Scan Clinics & Centres at Jamshedpur City.

(b) Employee and dependent family members are also entitled to Travelling Allowance for their journey to obtain specialised medical attendance and /treatment on referral by UCIL Hospital from their place of work to the company's recognised hospitals located other than Jamshedpur City.

#### 11. Entitlement of Travelling Allowance

- (a) The entitlement of Travelling Allowance for journey to obtain appropriate medical attendance/treatment from company's recognised hospitals, Pathological, Radiological Laboratories/Clinics etc. at Jamshedpur is notified as at Annexure'D'.
- (b) The Entitlement of Travelling Allowance for journey to obtain specialised medical treatment from company's recognised hospitals situated other than Jamshedpur City will be entitled class of the employee concerned as per entitlement notified under UCIL T.A. Rules.

#### 12. <u>Daily Allowance</u>

The patient (employee or dependent family members) and also Escort/Attendant are entitled to Daily Allowance for the period of journey undertaken by rail, road and air as per entitlement. No Daily Allowance is payable for halt/stay.

#### 13. Grant of Advance

Company may consider grant of advance as under:-

- (a) The advance would be admissible when an employee or a member of his family is being referred by UCIL Hospital to the Specialised hospitals other than company's recognised hospital.
- (b) Travelling Allowance Advance for the employee or a member of his family who is being referred by UCIL to the company's recognised hospitals situated other than from Jamshedpur City.

The employee is required to make an application to the Chief Medical Officer, UCIL for grant of advance and Chief Medical Officer there upon will decide the quantum of advance not exceeding Rs.20,000/- in each case depending upon the nature of case.

However; where the quantum of advance will be more than Rs.20,000/- consideration of grant of advance will be subject to approval of Director(Finance).

The advance so granted will be adjusted on submission of Medical Claim/Bill within a period of one month from the date of his discharge from the hospital.

#### 14. Advances to Wife/Legal heir

In exceptional circumstances in case of serious illness/accident where the employee being the patient is unable to apply for the advance, the advance may be sanctioned by the company on the basis of an application made in his behalf by the wife of the employee or other legal heir in writing.

#### 15. Reimbursement in relaxation of these rules in Emergent Cases.

Medical attendance and treatment under these rules from the private hospital is inadmissible. However in emergent cases involving accidents, serious nature of disease etc., the person on the spot either being employee or dependent family member may use his/her discretion for taking the patient for treatment in a private hospital in case no Government or company's recognised hospital is available nearer than the private hospital. The Chief Medical officer will decide in merit of the case whether it was a case of real emergency necessitating admission in a private institution and settle the medical bill to the extent admissible only after obtaining approval of the Chief Executive.

#### 16. <u>Submission of Medical Bill</u>

The employee is required to submit except where advance is granted his or her Medical Bill within 03(three) months from the last date of visit to the Hospital. In exceptional cases delay in submitting medical bill could be condoned to a maximum period of 03(three) months from the last date of normal submission of medical bill.

#### 17. <u>Inadmissible allopathic medicines</u>

Company will follow the list of inadmissible allopathic medicines notified by Central Government from time to time in CS(MA) Rules.

#### 18. Procedure for referral to hospitals recognised by the company etc.

The Chief Medical Officer is required to obtain prior approval of the Chief Executive before a patient is referred to any of the hospitals recognised by the company other than hospitals recognised by the company and situated at Jamshedpur city.

#### 19. Provision of transport as well as Ambulence

#### For Entitled Patient

Company will provide transport for attending UCIL Hospitals at Jaduguda & Narwapahar to an employee and his/her dependent family members on prescribed rates. The movement of such transport for medical purpose will be from colony to Hospital concerned and vice versa. The rate and frequency of trips of the transport will be notified by Administration Department concerned.

So far facility to provide Ambulance to the entitled patients is concerned, the Chief Medical Officer/Medical Officer of UCIL Hospital is authorised to provide the same considering seriousness and/or emergent nature of case.

#### 20. For Non Entitled Patients

Providing of Ambulance to non entitled patients within 6 Kms. (up and down combined) from UCIL Hospital to any hospital at Jamshedpur (up and down mileage not exceeding 100 Kms.), UCIL Hospital to any hospital at Ranchi will be subject to the recommendation of Chief Medical Officer/Medical Officer considering seriousness and/or emergent nature of case.

The tariff leviable for the use of Ambulance by the non- entitled patient is as at Annexure-'E' and is subject to revision from time to time by Administration Department.

#### 21 Medical treatment/facilities to the Non-entitled Patients

Company also provides medical treatment & allied facilities to the non-entitled patients on chargeable basis in UCIL Hospitals.

The various rates/tariffs chargeable for different mode of investigations treatments, operations etc. and payable by the non- entitled patients is enclosed herewith as at **Annexure-'F'** and is subject to revision from time to time by Admin Department.

#### 22 Power to remove difficulties and amendment

If any difficulty arises in giving effect to any of the provisions of this Rules, the company may refer the matter to the Chief Executive for decision and his decision will be final.

The company reserves the right to amend any of the provisions of these rules.

The entitlement of Travelling Allowance for journey to obtain medical attendance and treatment from company's recognised hospitals, Pathological, Radiological Centres etc. at Jamshedpur will be as under:-

#### **Employees of Jaduguda & Bhatin Mines**

- (i) Rickshaw/Auto Rickshaw charge From Jaduguda Colony to Rakha Mines Railway Station.
- Rs.6/- per head each way.
- (ii) Auto Rickshaw/Mini Bus charge from Tatanagar Railway Station to company's recognised hospitals & pathological centres etc.
- : Rs.6/- per head each way.
- (iii) Train fare in the entitled class between Rakha Mines Railway Station and Tatanagar Railway Station and vice-versa.

: Railway fare as per entitlement.

#### Note:-

Employees on referral to Mercy Hospital and ADMH, Baridih are entitled to the fare by Mini Bus over and above the fare as stipulated in clause-(ii). If an escort is permitted, the escort is eligible to travel as per entitlement of the patient so escorted. Employees entitled to travel by Ist Class and above by rail between Rakha Mines & Tatanagar Railway Station and vice-versa are required to produce Rail ticket or other documentary proof.

iv) Employees who use the mode of conveyance for which they are entitled for conveyance reimbursement like Motor Car/Motor Cycle/Scooter/Moped or any other mode of conveyance and attended place of referral at Jamshedpur, will be be paid lump sum amount.

# : (a) For those entitled for Motor Car

Total Rs.200/- per visit (including escort, if any).

(b) For those entitled for Motor Cycle/ Scooter
Rs.120/- per
Visit (including

Escort, if any).

#### (c) For those entitled for Moped

Rs.80/- per Visit (including Escort, if any).

#### For Employees of Narwapahar

(i) Bus/Mini Bus fare from Narwapahar : Rs.5/- per head to Sakchi and vice-versa each way.

(ii) Rickshaw/Auto Rickshaw fare : Rs.5/- per head between Bistupur/Sakchi and each way.

Company's recognised hospitals and Pathological centres etc.

#### **Note:**

Employees on referral to Mercy hospital and ADMH, Baridih are entitled to the fare by Mini Bus over and above the fare as stipulated in clause –(ii).

(iii) Employees who use conveyance owned by them, such as Motor Car/Motor Cycle/Scooter/Moped as per entitlement and attended places of referral at Jamshedpur, the reimbursement will be as under:-

a) For Motor Car : Rs.150/- per visit

(including escort, if any).

b) For Motor Cycle/Scooter : Rs.90/- per visit

(including escort, if any).

c) **For Moped** : Rs.60/- per visit

(including escort, if any).
