The pre-qualification criteria for Bearing Manufacturer are as under :

- 1) The party should be an Antifriction Bearing manufacturer.
- 2) The party should have wide network of distributors throughout the country. They must have authorized stockiest & recognized importer at Kolkata or Jamshedpur.
- 3) Authorized stockiest & recognized importer must facilitate pre-dispatch inspection by the manufacturer. Third party inspection is not acceptable.
- 4) Product: The party should have wide range of product:
  - a. Ball Bearing; 10mm bore to 300mm bore.
  - b. Cylindrical & Taper roller Bearing 15mm bore to 300mm bore
  - c. Spherical Bearing: 40mm to 375mm bore
  - d. Needle Bearing upto 150mm bore
- 5) Rare sizes of above ranges may be catered by their global presence.
- 6) Financial:
  - a. Turnover: Minimum 100 crores during last three (03) FY in India.
  - b. They must have earned profit during last three (03) years
