DETAILED NOTICE INVITING TENDER

Sealed item Rate Contract tenders are invited on behalf of the Chairman and Managing Director, Uranium Corporation of India Limited, Jaduguda for the work "Hiring of tractor and trolleys with hydraulic system with driver for Turamdih Estate.

1. The Tender shall be in prescribed form and it shall be valid for a minimum period of **six** months from the date of opening of Tender. Should the Tenderer modify or withdraw his tender within the said period of six months from the date of opening the Tender, Earnest Money deposited by the Tenderer shall be forfeited and no tenders will be issued further to such tenderer unless corrigendum issued .
2. The works are required to be completed within 24 (**Twenty Four months**) from the date of commencement which the engineer-in-charge issues by written orders to commence the work as per LOI/Work order, in accordance with the phasing, if any, indicated by the Corporation in the Tender documents.
3. Normally Contractor whose names are borne on the approval list of Contractor of C.P. W. D / M. E. S or local reputed/experienced Contractors will be permitted to Tender. Not more than one Tender shall be submitted by a firm of Contractors against the same N. I. T.
4. Chairman & Managing Director, UCIL shall be the Accepting Officer hereinafter referred to as such for the purpose of this Contract.
5. **Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their Tenders as to the nature of the ground and sub soil as far as is practicable) the form and nature of the site, the means of access to the site the accommodation they may require and general shall themselves obtain all necessary information as to risks, contingencies and circumstances which may influence of effect their Tender. A Tenderer shall be deemed to have full knowledge of the site whether he inspect it or not and no extra changes consequent on any misunderstanding or otherwise shall be allowed.**
6. Submission of a Tender by a Tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of considerations and rates at which stores, tools and plants etc will be issued to him by the corporation and local conditions and other factors bearing on the execution of the work.

Special care shall be taken to write rates in figures as well as words and the **rates in words only** in such a way shall be considered for calculation of quoted value.

9. In the case of item rate Tenders, only rates quoted shall be considered. Any Tender containing percentage below/above any scheduled rates quoted is liable to be rejected.

10. The Tender for the works shall not be witnessed by a Contractor or Contractors who himself /themselves has / have tendered or who may and has/ have tendered for the same works. Failure to observe this condition shall render the Tender of the contractor tendering as well as of those witnessing the tender liable to be rejection.

SPECIAL CONDITIONS

SITE INVESTIGATION:

1. The Tenderers are advised to visit the site to acquaint themselves as to the nature and location of the work, the general and local conditions particularly those bearing upon transportation, disposal handling and storage of materials, availability of labour, water or similar physical conditions of the site, the formation and conditions and level of the ground the character quality and quality of surface and sub-surface materials to be encountered, including sub-soil water levels the character of equipment and facilities needed preliminary to and during the progress of the work and all other matters which can be of in any way affect the work the cost thereof under the contract.
2. No material shall be issued from store.
3. The contractor has to follow strictly the Government Labour Acts, which are and will be in force during the period of execution of work. All necessary arrangements for Laborers Security will have to be made by the Contractor at his own cost.
4. **SALES TAX** :Sales Tax/Works Tax as per rules shall be recovered at source on gross value of the work executed and balance amount on this account shall be deposited by the contractor directly to sales Tax authority.
5. In case of stoppage of work by local people/Bandh or any other reasons no idle changes will be paid by corporation towards Labour, plant and Machinery etc. to the contractor for this work
6. In case payment of laborers engaged for this work has not been made on stipulated payment day corporation shall compel the contractor to stop the work and necessary action will be taken.
7. Contractor shall have to provide the facilities under the provision of Contract Labour (Regulation & Abolition) Act, 1970 – Section – 16, 17, 18 and 19, Chapter – V – “Welfare and Health of Contract Labour”.
8. Contractor will carryout all works upto a total variation of $\pm 10\%$ (Ten) on the contract price and all quoted rates shall remain firm within this limit.
- 9. No escalation on any account whatsoever shall be paid by corporation for this work.**

10. COMPENSATION FOR DELAY:

If the Contractor fails to maintain the required progress in terms of the condition of this Contract or to complete the work and clear the site on or before the Contract or extended date/period of completion, he shall, without prejudice to any other right or remedy of the Corporation on account of such breach, part as agreed compensation amount calculated as stipulated below or such smaller amount as the Contract value of the work for every week that the progress remains below that specified or that the work remains incomplete.

This will also apply to items or group of items for which separate period of completion has been specified.

For this purpose the term 'Contract Value' shall be the value at Contract rates of the work as ordered.

10.1 Provided always that the total amount of compensation for delays to be under this condition shall not exceed the under noted percentage of the Contract value of the item or group of items of work for which a separate period of completion is given.

10.2. The amount of compensation may be adjusted or set off against any sum payable to the Contractor under this or any other Contract with the Corporation.

11. MEDICAL CARE: The contractor shall be fully responsible for any first aid and emergency medical treatment to his employees. Necessary arrangement for this purpose shall be made by the contractor at the site. In serious cases medical facilities of UCIL may be available on chargeable basis.

12. MEDICAL SUPERVISION: The medical supervision of the contractor over his employees shall include anti-malaria measures, vaccination against small pox, inoculations against cholera, typhoid fever and other infectious diseases. Employees suffering from infectious diseases shall be removed from the site as soon as detected. If any case of infectious disease be discovered among the employees it must at once be reported to the Engineer. The contractor shall abide by the provision of the Employees State Insurance Scheme where applicable.

12. The Engineer wherever appears in the contract shall mean Engineer-in-charge of the work.

13. Contractors shall strictly abide by the security rules and regulations enforced by the owner time to time. The contractor shall provide proper identity cards, badges etc. to his employees wherever directed by the engineer.


14. All other terms and conditions like termination of contract etc. will be governed as per UCIL's General conditions of Contract of Tender Document. The same can be seen from the office of Chief Supdt. (Civ), at Turamdih Mines. No claim in the matter shall be entertained in future.

15. All the rates should be inclusive of all Taxes including Service Tax but UCIL will not deduct/deposit any service tax as this type of contract does not fall under Reverse charge mechanism. Contractor has to deposit Service Tax themselves.

16. The Tractor & Trolleys intended to deploy for this contract should be in excellent running condition and complete with good seats, glasses, tyres & stepney etc. and should be provided with driver and helper . The Tractor & Trolleys offered should be the contractor's own vehicle. The capacity of the Trolleys should be Minimum 100 cft. The Tractor should not be manufactured earlier than the year 2012.

17. The contract would be for a period of Six months and may be extendable, if necessary. UCIL has the sole right to extend / terminate the contract beyond Six months after giving prior notice of one month to the contractor. However, even with in the initial one year contract period, if the performance of the contract is found to be poor, like many break /stoppage of the vehicle for any reasons whatsoever shall be attributable to the contractor. UCIL has the sole right to cancel the contract after giving prior notice of one month to the contractor.

18.The duty of the Tractor & Trolleys shall be 12 hours i.e. 07.00 AM to 07.00 PM.

19. Hire charges for the Tractor & Trolleys shall be paid monthly on submission of contractor's bill along with duly signed log book which shall be provided by corporation to the successful tenderer.

20. All the documents connected with the vehicles 'C' Book, Drivers License etc. should be made available with the vehicle.

21. Driver/Helpers must be well behaved or shall be suitably substituted failing which contract shall be terminated without any prejudice.

22. No accommodation shall be provided for the personnel deployed for Tractor & Trolleys and the contractor shall be responsible for the same.

23. Tenderers with valid address and telephone number(s) where they can be contacted in all duty hours shall only be considered. Tenderers without valid address and telephone numbers shall be rejected.


24. Vehicle will be used mainly for transportation of disposal of rubbish/waste from dust bin of Mines area/scrap material/disposal of jungle/issue pipe fittings materials/water tanks/materials shifting during games/function.

25. UCIL has the right to inspect the Tractor & Trolleys in detail before processing of the tender and if the quality is not found good, the tender would be rejected without assigning any reason whatsoever. UCIL is the sole authority to decide on the quality of the vehicle

26. *Taxes & Insurance:* Tenderer should consider all the applicable taxes **including service tax** before quoting their rate. All the Taxes (excluding service tax) as applicable shall be deducted from their bills by Corporation. Insurance of the vehicle and their personnel shall be provided by successful tenderer at their own cost. UCIL shall not pay taxes of any nature against this work to the contractor. The quoted rate must be firm throughout the period of contract

27. All valid RTO documents, necessary road permit and other documents as required related to commercial vehicles must be available with the contractor and the same should be furnished if required. In case the vehicle is held up by the police /RTO personnel for an offence against non compliance of law, the responsibility shall be of the contractor. If the vehicle is held up by the police /RTO/any other agency & not being used for UCIL, penalty clause of this special conditions shall apply. Insurance means insurance for vehicle as well as drivers/helpers.

28. All the maintenance of Tractor & Trolleys will be borne by the contractor at their own expenses.

29. The Engine oil, lubricants as required are to be filled up by the contractor only and no extra charges would be paid. Rate of diesel will be considered as on 1st day of every month. at diesel outlet in Jamshedpur which shall be as per the actual rate of diesel subject to production of documents from diesel outlet.

30. The contract amount is arrived in two parts i.e. One is fixed amount; other is calculated on the kilometers run by the vehicle, as signed in the log book. For example if the vehicle has run for say, 1200 Km. Then the amount to be paid is = (fixed amount) + 1200Km x rate of diesel*.

Note: *No other escalation shall be payable against this work.*

31. There shall be no restriction on km run by the Tractor & Trolleys.

32. The monthly rent includes Sundays and holidays also in a month. You will be allowed to take the vehicle for repair/maintenance on one day in a month, i.e., any one Sunday subject to the convenience of the user with prior permission. For repairing/maintenance purposes the vehicle is allowed reimbursement of the maximum of 02.00 Hrs only per month.

33. The Tractor & Trolleys is to be parked as directed by the Engineer –in- charge at the designated place at the risk of the contractor.


34. Identity card /Gate pass would be issued to driver of the vehicle to enter into any UCIL premises.

35. The contractor should comply with provisions of Contract Labour Act (Regulation & Abolition) 1970 and central rules framed there under and minimum wages act 1948.

36. The contractor must ensure that the diesel is filled to the full tank capacity. The vehicle shall not be allowed to go out for filling of diesel .The contractor has to arrange to fill diesel in Tractor at Turamdih Mines main gate for which only half an hour shall be allowed. No fuel or lubricants or any spares shall be provided by UCIL.


37. **PENALTY:** In case of non availability of the vehicle due to break down, absenteeism or for any other reason attributable to the contractor, a penalty of double the hourly rate(derived from the fixed monthly rate) per hour of non availability shall be imposed if suitable substitute is not provided with in an hour apart from reducing the non availability period from fixed charge.

SAFETY OF CONTRACTOR'S EMPLOYEES

1.0 The Contractor shall at all times, take all reasonable precautions for the safety of employees, including those of sub-contractors in the performance of his contract and shall comply with all applicable provisions of both Central as well as the State Safety Laws, in addition to the safety provisions already included in the Safety requirements recommended by the V. T. Centre, Narwapahar/Turamdih for a specific contract.

2.0 In the event that the contractor fails to comply with these provisions, the Engineer-in-charge may, without prejudice to any other legal or contractual rights, issue an order stopping all or any parts of the work, thereafter a start order for resumption of work may be issued at the discretion of the contracting office. The contractor shall make no claim for an extension of time or stoppage.

3.0 Contractor shall have a full time Safety officer/Engineer when the contractor employs 500 or more persons or when engaged in specially hazardous work. In the case of contractors employing fewer than a persons, his safety representative shall be employed in high supervisory capacity and his safety duties may be in addition to other technical or administrative duties.

4.0 Contractor shall have at least one person fully trained in First-Aid present at the site of work all the times.- their personnel

- UCIL property or personnel

- property or personnel of other contractors working on the site

4.1 Contractor must report to V. T. Centre, Narwapahar/Turamdih through the Engineer-in-charge immediately on becoming aware of any accident of Type – A (see Appendix – 1) giving the following information

Name of the informant

Nature & location of incident being reported

Name of Supervisor/engineer-in-charge, Location and Telephone No where he can be reached


4.1.1 Contractor shall submit their investigation reports through their Engineer-in-charge, to V. T. Centre immediately but not later than three working days after the occurrence of accident in the Form – A (see Appendix -2)

4.2 In the case of Type – B accidents (see appendix -1), Contractor shall submit their investigation reports through their Engineer-in-charge, to V. T. Centre immediately but not later than three working days after the occurrence of accident in the Form – A

4.3 Monthly summary of accidents and cases of fire shall be prepared by each contractor in Form – B (see Appendix – 3) and be sent to V. T. Centre, Narwapahar/Turamdih by the seventh of next month.

4.3.1 Principal contractor shall report the man days lost and occurrence of accidents under the jurisdiction of sub-contractors.

4.3.2 Contractor shall submit a narrative report on safety activities and fire incidents for each month along with Form – B. The review should contain such items as personnel and programme change, major project started and major problems.
