4. 5. 6. Preference to Make in India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 8. - 1) Bidders shall submit their offer strictly as per specification and Scope given in the bid, Bidders shall also comply additional specification (if any) given in the bid, failing which offer will liable to be rejected. Conditional offer will also liable to be rejected.

7) **Scope of Work:**

- a. **Scope of Supply:** Bidder has to supply all material mentioned in Bill of material of the tender. Bill of material has been prepared carefully, however there may be some omission of material which may be required for completing the work. It is the bidder responsibility to point out such missing material. If the bidder fails to point out such missing material and afterwards it is felt necessary that certain material is required to complete the job, it shall be contractor responsibility to arrange the material without any cost implication.
- b. **Scope of Service:** Erection, commissioning, trial run of all the supplied hardware. Underground OFC cable laying through trench cutting, cable laying (in HDPE Pipe) and its reinstatement, Splicing, termination of OFC and testing the link with OTDR is also in the scope of bidder. System Programming & configuration, configuration of VLAN, testing and trial run is in the scope of the bidder. Bidder shall also be responsible for rectification of any problem reported within one year from the date of handing over the system to UCIL.

2. The OEM of the CCTV equipment's should not be debarred/banned/blacklisted or imposed sanctions by any Country or Government institution globally. Bidder should submit OEM declaration regarding the same.
3. Bidder shall submit the detailed BOM, Brochure of the equipment offered duly verified and certified by the respective OEM and same model should be displayed on OEM website.
4. Any representation through a Dealer/ Distributor/ Joint Venture/ consortium shall not be treated as OEM. It should be supported with necessary statutory documents and undertakings on OEM letterhead as required.
5. All Camera, Housing, NVR and its Solution should be of Single OEM.
6. OEM must provide a certificate that the proposed model of CCTV products must not become obsolete within a period of 3 years in case it gets EOL due to technology advancement then OEM will support with equivalent or higher model. Also, any product which is nearing the End-of-Sale (EoS) must not be proposed in the solution.
7. Bidder will have to submit OEM Authorization on OEM letter head with bid number for Quoted Product.
8. Bidder should submit valid STQC Certificate of Product Evaluation failing which their offer will be outrightly rejected.

9) **Special Terms & Condition**

a. **Payment Terms:**

i. **For supply part:**

- f. Depth of the trench cutting should be 1.5 ft below the ground for cable laying on soft soil and on road depth should be 2 ft below the ground level and refilling should be done as it was. (Soil/Concrete)
- g. The entire supplied item shall be guaranteed/warranted for trouble free operation 3 years from the date of handling over of the system. In case of any problem the bidder shall make arrangement to repair/replacement of faulty device free of cost.
- h. For road cutting prior permission shall be taken from UCIL authorities (Engineer In-Charge) & such type of cutting job shall be executed by the party at their own cost.
- i. Contractor will take insurance of their workman before commencement of job and insurance period shall be sufficient enough that the work is completed within the period. In case the insurance needs to be extended for any reason to complete the work, the same shall be extended by party as their own cost.
- j. Any damage of existing nearby structures/Pole/Cable/facility are to be repaired/replaced/reinstated as it was by the contractor at their own cost.
- k. Job Completion Period : 05 months from the date of placement of order.**
