2. 7. 8. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to be as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder

must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at the local value addition is made along with their bid, failing which no purchase preference shall be granted. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

10. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rate. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

2. Scope of Supply

3. Generic

- 1) Bidders shall submit their offer strictly as per specification and Scope given in the bid, Bidders shall also comply with any additional specification (if any) given in the bid, failing which offer will be liable to be rejected. Conditional offers will also be liable to be rejected.
- 2) **Related Party Clause:** Subsequent to bid opening, if it is found that bids submitted by related parties in which there seems to be collusion are liable to be rejected. Parties are considered to be related if one party has the ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.
- 3) **Any document required during submission of bid wherever mentioned in the bid &/or a requirement for placement of P.O (EMD/SD/SAMPLE (if required)), shall be sent through speed post only to the proper address as mentioned in the bid/P.O. only.**

- 7) Product catalogues with cross sectional drawing along with part list & MOC details must be submitted by the party along with offer.
- 8) Overall dimension along with weight of the valve must be mentioned with the offer.
- 9) Material test certificate & pressure test certificate to be furnished with supply of the material.

- 11) **DISPUTE RESOLUTION MECHANISM AND JURISDICTION:**
 - a. **CONCILIATION:** Notwithstanding anything contained in this contract, any disputes or differences which arise, which are to be settled amicably between the parties with their authorized representatives, shall be resolved through conciliation.

- b. **MEDIATION:** Any disputes or differences, which are not settled amicably through conciliation, then the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be as prescribed in the Mediation Act, 2023 amended from time to time.
- c. **AMRCD:** Any disputes or differences between the parties are not settled amicably with conciliation and mediation, then such disputes or differences shall be resolved through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretation and application of provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, entered into also between CPSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
- d. **ARBITRATION:** Any disputes or differences where clause no. (c) is not applicable, the parties may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the value of the dispute and not the value of the contract which may be much higher. In all other cases, arbitration shall not be a method of dispute resolution arising out of this contract.
- e. **JURISDICTION:** If the matter is not resolved through above means, the dispute shall be resolved in the court of law at Jharkhand only.
