- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. - 8. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - 10. - b. **MEDIATION**: Any disputes or differences, which are not settled amicably through conciliat ion, then either of the parties, may approach for mediation to settle under mediation Act, 2 023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended fro m time to time.
- c. **AMRCD**: Any disputes or differences between the parties are not settled amicably with co nciliation and/or Mediation, then such disputes or differences shall be resolved through Ad ministrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences

nces relating to interpretation and application of the provisions of commercial contract(s) b etween Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between C PSE(s) and Government Department(s) / Organization(s) shall be taken by either party for i ts resolution through AMRCD.

- d. **ARBITRATION**: Any disputes pr differences where clause no. (c) is not applicable, the part ies may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provi ded the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with refer ence to the value of the dispute and not the value of the contract which may be much high er. In all other cases, arbitration shall not be a method of dispute resolution arising out of this contract.
- e. **JURISDICTION**: If the matter is not resolved through above means, the dispute shall be re solved in civil court of law at Jharkhand only.
