## 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity  $\div$  Original quantity)  $\times$  Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## **Additional terms & conditions.**

- 1) Bidders shall submit their offer strictly as per specification and Scope given in the bid, Bidders shall also comply additional specification (if any) given in the bid, failing which offer will liable to be rejected. Conditional offer will also liable to be rejected.
- 2 ) Related Party Clause: Subsequent to bid opening, if it is found that bids submitted by related parties in which there seems to be collusion are liable to be rejected. Parties are considered to be related if one party has ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.

#### 5) **DISPUTE RESOLUTION MECHANISM AND JURISDICTION:**

- a. **CONCILIATION**: Notwithstanding anything contained in this contract, any disputes or differences whatsoever, which are to be settled amicably between the parties with their authorized representa tives, shall be resolved through conciliation.
- b . **MEDIATION**: Any disputes or differences, which are not settled amicably through conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.
- c. **AMRCD**: Any disputes or differences between the parties are not settled amicably with conciliation and/or Mediation, then such disputes or differences shall be resolved through Administrative Mech anism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretat ion and application of the provisions of commercial contract(s) between Central Public Sector Enter prises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Government Department(s) / Or ganization(s) shall be taken by either party for its resolution through AMRCD.
- d. **ARBITRATION**: Any disputes pr differences where clause no. (c) is not applicable, the parties may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the value of the d ispute and not the value of the contract which may be much higher. In all other cases, arbitration s hall not be a method of dispute resolution arising out of this contract.
- e. **JURISDICTION**: If the matter is not resolved through above means, the dispute shall be resolved in civil court of law at Jharkhand only.

#### 6) SCOPE OF WORK:

Fabrication and Rubber lining work including surface preparation and Painting work including surface preparation of the outer surface as per UCIL specification.

#### 7) INSPECTION & TESTING:

- a. Necessary material test certificates, inspection reports, hydro test reports, etc. shall besubmitted to UCIL for review &verification. Test certificates shall be issued for each lot of raw material used in the lining rubber, corresponding to specific weight and traction resistance.
- b. Testing of Rubber Lining shall be done in accordance with the TechnicalSpecification and relevan t standard codes.
- c. Bidder should furnish performance guarantee as per applicable standard guarantee for themanuf acture, material and safe operation of the equipment.
- d. UCILmay witness the test at Bidder's works and a notice of minimum two (2) weeks shallbe give n for attending the inspection.
- e. Bidder to arrange all calibrated gauges, Instruments during inspection at works.All inspection, m easuring and test equipment used by Bidder shall be calibrated periodicallydepending on its use a nd criticality of the test/measurement to be done. The Bidder shallmaintain all the relevant records of periodic calibration and instrument identification, and shall produce the same for inspection by the Owner. Wherever asked specifically, the Biddershall re-calibrate the measuring/test equipment in the presence of UCIL representative /Inspector.
- f. Bidder may refer -Typical Quality Plan for Inspection & Testing Requirement.
- g. For painting requirement, bidder to refer -Painting Specification.
- h. Final test by UCIL for the specified specification at UCIL site shall be final & binding.

## 8) PERFORMANCE GUARANTEE:

The lining shall be guaranteed for uninterrupted operation of Plant. Performanceparameters to be guarante ed by the vendor and tolerances permitted shall be as indicated in the data sheet. Rubber lining or any portion thereof is liable for rejection, if it fails to give any of the guaranteed performance parameters. The lining should be guaranteed for faultless material and workmanship and **also for a period of 18 months from t he date of handing** over. During Guarantee period any defects noticed due to faulty material andworkman ship shall be rectified by vendor free of cost.

#### 9) SURFACE PREPARATION FOR RUBBER LINING:

a. Vessel should be fabricated and welded in accordance with specific codes. Welds shall havea rou

nd and smooth surface suitable for applying rubber liningshall conform to IS 4682-1.

- b. The steel surface shall be degreased, shot/grit blasted to SA 2  $\frac{1}{2}$  as specified in DIN EN ISO 1294 4-4 and chemically cleaned with any suitable degreasing agent before bonding with rubber. and a roughness grade "medium (G)" as specified in DIN EN ISO 8503-1 must be achieved; minimum surface roughness Rz = 50  $\mu$ m. The shots/grits shall be as per IS 4606 Grade G12. The metal plates must be degreased before mechanical cleaning. After mechanical cleaning and before application of primer adhesive the metal plates should be cleaned with dry air. It has to be ensured before bonding that the metal surface is free from dust, rust, moisture, metal oxide, oily contaminants and other foreign matter.
- 10) **RUBBER LINING SPECIFICATION:** Rubber lining: <u>Unvulcanised multi-ply Soft Natural Black Rubber</u> shall be u sed for lining and the lining shall conform to**IS 4682-1.**12) **PRIMERS AND ADHESIVE SYSTEM:** After blastin g, the formation of new rust must be prevented by suitable measures, e.g., immediate application of a primer. The adhesive system shall be such that the required level of adhesion between the lining and the metal is achi eved upon completion of the lining process. The adhesive system consists of one or more individual layers of a dhesive and primer. The adhesives shall be applied to the primed metal surface, solvents in the adhesive bein g allowed to evaporate between the application of successive coats or subsequent application of the lining.
- **11**) **PRIMERS AND ADHESIVE SYSTEM:**After blasting, the formation of new rust must be prevented by suitable measures, e.g., immediate application of a primer. The adhesive system shall be such that the required level of adh esion between the lining and the metal is achieved upon completion of the lining process. The adhesive system con sists of one or more individual layers of adhesive and primer. The adhesives shall be applied to the primed metal su rface, solvents in the adhesive being allowed to evaporate between the application of successive coats or subseque nt application of the lining.

#### 12) LINER APPLICATION:

- a. No rubber stock shall be applied when the ambient temperature of the work is below 20° C or bel ow the dew point of the surrounding air. Adhesive shall not be applied when the surrounding air has either a relative humidity above 85% or a temperature below 20° C.
- b. The rubber stock shall be joined with a 45-degree skived edge overlapping atleast 3-6 times of the rubber thickness (max 32mm).
- c. The rubber lining work shall be done by generally accepted techniques and toolsthat no air is tra pped and air behind the lining should be removed completely.

#### 13) VULCANIZATION:

- a. All rubber lining pipes shall be vulcanized by the saturated steam in a Autoclave. The required pr essure, temperature and vulcanizing hours shall be chosen for the vulcanization of each rubber lining by Vendor to achieve desired properties.
- b. If the hole to ventilate the air behind the lining is to be necessary to avoid airpockts, it shall be made by the fabrication of the rubber lining.
- 14) **CURING**: The curing procedure used shall be the responsibility of the vendor. The method used shall assure c omplete cure of the rubber stock and procedurethe desired physical properties.
- 15) **PATCH REPAIRING:** Where patch repairing is required rubber lining will be removed up to a point where linin g is satisfactory and has firm adhesion to the metal. The metal will be cleaned lining edge skived to 45-degree cement applied and rubber stock. No patches are permitted on flanges faces. All cured patches shall meet the requirements specified for the original liningmaterial.
- 16) **PAINTING SPECIFICATION:** Outside surface shall be painted with each 80 DFT of two coats of red oxide zinc chromate primer followed by each 50 DFT of two coats of Synthetic Enamel finish paint. Paint should be Smoke Grey 1st quality.
