- 1) **Scope Of Supply:** Supply of Caustic Soda Flakes Rayon grade containing 99.5% NaOH by mass on d ry basis as perlS:252/1991 (3rd revision) packed in 50 kg HDPE woven bags lined with polythene du ly unloaded basis at our Turamdih Site. Turamdih is located 06 KM (approx.) from Tatanagar Railwa y station. In case of emergency, truck loaded consignment material shall be diverted to unload at Ja duguda Plant which is approx. 25 KM from Tatanagar Railway Station without any financial implicati on. Such information of diversion shall be intimated to the party by HOD (Stores) in mail at least se ven days before the diversion of the specific lot. No amendment will be given for such diversion.

8) Pro-Rata Deduction on the cost of material for NaOH Content:

Analysis report of UCIL lab will be final and binding. Pro rata deduction will be made for material bel ow the specified grade as under;

- a) 99.5% to 97%: no deduction shall be applicable.
- b) Below 97% up to 96%: single pro-rata deduction on the cost of material.
- c) Below 96%: Rejection of material.
- d) In Case of stock out situation, material below 96% will be accepted by UCIL with double pro-rata deduction on landed cost of material received.

- g) Analysis report of UCIL shall be treated as final & binding for the sample collected 0.5 &above % ofNaOH will be rounded off to next integer & same will be applicable below 0.5% NaOH for rounding off to nearest integer.

For Example:- If analysis value comes to 94.49%, it will be rounded of to 94% & if it comes 94.50% than it will be rounded of 95%.

- h) Since NaOH hygroscopic material, re-analysis of material will not be allowable.

 - b) **MEDIATION**: Any disputes or differences, which are not settled amicably through conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to tim e.
 - c) AMRCD: Any disputes or differences between the parties are not settled amicably with concili ation and/or Mediation, then such disputes or differences shall be resolved through Administrat ive Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating t o interpretation and application of the provisions of commercial contract(s) between Central Pu blic Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Governmen t Department(s) / Organization(s) shall be taken by either party for its resolution through AMRC D.
 - d) **ARBITRATION**: Any disputes pr differences where clause no. (c) is not applicable, the parties may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the v alue of the dispute and not the value of the contract which may be much higher. In all other cas es, arbitration shall not be a method of dispute resolution arising out of this contract.
 - e) **JURISDICTION**: If the matter is not resolved through above means, the dispute shall be resolv

ed in civil court of law at Jharkhand only.
