- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 5. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. - 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered

product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

- 8. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. - 9. - 2) Bidders shall submit their offer strictly as per specification and Scope given in the bid, Bidders shall also comply additional specification (if any) given in the bid, failing which offer will liable to be rejected. Conditional offer will also liable to be rejected.
- 3) **Related Party Clause:** Subsequent to bid opening, if it is found that bids submitted by related par ties in which there seems to be collusion are liable to be rejected. Parties are considered to be relat ed if one party has ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.

a) Considering smooth supply of this critical material, efforts will be made to keep at least two source of supply and try to distribute the bid quantity in the ratio 60%: 40% among the particip

ated bidders based on their merit in hierarchy and subject to matching their quoted rate with L 1 bidder's rate.

However, MSE/MII and Gem splitting rules shall prevail over the said splitting clause and subsequent to price bid opening and during the time of splitting of order quantity, options allowed by Gem Portal for splitting of quantity shall be applicable and bin ding to the participated bidders.

- b) In case none of the bidders has matched their quoted rate with L1 bidder's rate, then entire qu antity may be awarded to L1 bidder only.

9) Product must be supplied in 25 Kg polylined HDPE bags. Any other type of packing or packing with higher quantity mentioned shall not be accepted.

10) Selection Criteria:

- 100 gms. of sample along with details leaflet of product containing the viscosity toxicity, shear rate, molecular weight, chain length etc. is required to evaluate the offer without whi ch offer may be rejected.
- ii) Only solid powder/granular flocculent is acceptable, emulsion or gel etc. is not acceptable
- iii) Sample not performing well in lab testing as stipulated will be rejected.
- iv) Offer without sample & leaflet shall be rejected.
- v) Settling test shall be carried out with existing plant slurry for determination of rate of settl ing with the offered flocculent sample. Sample of flocculent giving poor rate of Settling during testing & evaluation as compared to the existing shall be rejected.

Settling test shall be carried out in the 500 ml graduated measuring glass cylinder of a standard make (Like Borosil) having accuracy as per IS 878 or ASTM. The settling rate of **500** ml Neutral Slurry with 26-28% (W/W) solids & others details as mentioned earlier with a flo cculent dose of (0.05% strength) 10 ml shall be such that it gives a clear liquor above the graduation point of 270 ml in the measuring cylinder at the end of **Five (5.0) minutes** aft er the slurry was mixed with flocculent & it was left in the measuring cylinder for settling. However if the settling rate is faster than the above mentioned range, the same sample shall also be qualified for consideration.

- vi) Only one sample shall be sent with offer for testing.
- vii) If more than one sample is sent, UCIL will pick any one random sample for testing & evolut ion.

11) Test Report:

The material supplied by you shall be analyzed in UCIL lab & UCIL's test report shall be treated as f inal & binding. Test report of the settling test shall be given only upon written request. The report s hall carry only the result of the sample supplied by the concerned supplier.

12) Acceptance & Rejection criteria of bulk supply of consignment:

Samples shall be drawn out from the supplied consignment bags for testing & evaluation to check t he quality against the original sample provided with tender. If the settling rate of slurry is similar to the sample provided against the tender bids then whole lot will be accepted. In case the settling rate of the slurry is deviates the specified limit (i.e. if the settled slurry volume reaches > **270 ml in 5 minutes)** then the material shall be rejected. The test report of UCIL will be final & binding

Note:

- 1) Material is required to be supplied on FOR-destination basis duly unloaded & insured basis.
- 2) As staggered delivery schedule given in the bid document, hence offline calculation of LD will be done by paying authority during the time of making payment to the supplier.
