#### 1. PRE-QUALIFICATION CRITERIA

Past Experience of Similar Services: The Bidder must have successfully executed / completed at least one single order of 80 % of the Estimated Bid Value or 2 orders each of 50 % of the Estimated Bid Value or 3 or ders each of 40 % of the Estimated Bid Value for similar service(s) in last seven (07) years to any Central / State Govt Organization / PSU / Public Listed Company. Copies of contracts / work orders and documentary evidence of successful execution / completion in support of Past Experience of Similar Services along with names, address and contact details of clients shall be uploaded with the bid for verification by the Buyer.

### ("Similar work means" - Work contract which includes supplying of manpower)

- i) The eligibility period shall be within the period of 7 years backwards starting from the last day of month previous to the publication date of BID.
- ii) The work experience of the bidder for those works only shall be considered for evaluation purpose, which is completed before the last date of month previous to the one in which the BID has been published on G eM portal. Hence, the works which are incomplete/ongoing, as on the last date of the month previous to the one in which the BID has been published on GeM Portal, shall not be considered against eligibility.
- iii) In case the work is started prior to the eligibility period of 7 (Seven) years (counted backwards starting f rom the last date of the month previous to publication date of BID) and completed within the said eligibility period of 7 years, then the year of experience of the work within the said eligibility period shall be only con sidered against the eligibility
- **2. GEOGRAPHIC PRESENCE:** Office registration certificate: Registered Office or at least one of the regist ered Branch Office of the bidder shall be located and registered within the geographical limits i.e East/West Singhbhum & Saraikela Kharsawan districts of Jharkhand State. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.

- **3. Penalty**: The contractor shall maintain daily attendance of 6 no. of skilled workman in every running m onth. Failure to maintain daily attendance of 6 no. skilled workman imposition of penalty shall be as follow s:
- i) No penalty shall be deducted from monthly running bill when 100% and greater or equal to 90% of avera ge daily attendance is maintained.
- ii) 2 % shall be deducted from monthly running bill when less than 90% and greater and equal to 75% of average daily attendance is maintained.
- iii) 3 % shall be deducted from monthly running bill when less than 75% and greater or equal to 60% of average daily attendance is maintained.
- iv) 5 % shall be deducted from monthly running bill when less than 60% of average daily attendance is mai ntained.
- **4.** Bidder shall submit ESI registration, EPF registration copy, GSTIN copy, PAN copy must be submitted alo ng with the bid.
- **5.** <u>Manpower Preference:</u> The Contractor shall give first preference to the persons who are already work ing in this contract, and then to others.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
