- 1. - 1) **SCOPE OF SUPPLY:** Supply of Ferric Alum Grade-IV confirming to IS-299:2012 at our Turamdih Si te, Unloading from truck and stacking at our stores /site stores /godown. Turamdih is located appro x. 06 KM away from Tatanagar Railway station.
- 2) Bidders shall submit their offer strictly as per specification and Scope given in the bid, Bidders shall also comply additional specification (if any) given in the bid, failing which offer will liable to be rejected. Conditional offer will also liable to be rejected.
- 3) **Delivery Schedule:** 10000 Kg per month from the date of Purchase Order. However delivery quan tity in each lot may vary by 10%.
- 4) Unloading of material at site is under the scope of the work of the supplier.
- 5) Material should be in 25 Kg naked solid from lumps/HDPE bags.
- 6) Test certificate should be furnished along with each consignment. Sampling of each consignment s hall be done at our end with grab sampling method and shall be analyzed in our lab. Our analysis s hall be treated as final and binding to both.

- 7) The analysis value will be rounded off to the nearest integer. Decimal fraction above or equal to 0. 5 shall be rounded off to next integer where as below 0.5 shall be rounded off to previous integer.
- 8) **Pro Rata Penalty:-** Ferric Alum Grade-4 confirming to IS-299 supplied should be having minimum 16% (% by mass) (Al<sub>2</sub>O<sub>3</sub>). For supply having less than 16% (Al<sub>2</sub>O<sub>3</sub>) by mass content, Pro Rata ded uction shall be effected on the basis of landed value of particular invoice as under:
  - a) If the (Al<sub>2</sub>O<sub>3</sub>) is below 16% but up to 13% Pro Rata deduction will be effected on the ba sis of landed value of particular invoice.
  - b) If the (Al<sub>2</sub>O<sub>3</sub>) content below 13% material may be rejected.
  - c) In case of (a) you will not be allowed to take back of material for replacement.
- 9) **Related Party Clause:** Subsequent to bid opening, if it is found that bids submitted by related pa rties in which there seems to be collusion are liable to be rejected. Parties are considered to be related if one party has ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.
