- 1. The minimum

local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. - 8. Any disputes or differe nces relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between C PSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
- d. **ARBITRATION**: Any disputes pr differences where clause no. (c) is not applicable, the part ies may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provi ded the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with refer ence to the value of the dispute and not the value of the contract which may be much high er. In all other cases, arbitration shall not be a method of dispute resolution arising out of t his contract.
- e. **JURISDICTION**: If the matter is not resolved through above means, the dispute shall be re solved in civil court of law at Iharkhand only.
