- 1. - b. **MEDIATION**: Any disputes or differences, which are not settled amicably through conciliation, then either of the parties, may approach for mediation to settle under mediation Act, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.
- c. AMRCD: Any disputes or differences between the parties are not settled amicably with concilia

tion and/or Mediation, then such disputes or differences shall be resolved through Administrati ve Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating t o interpretation and application of the provisions of commercial contract(s) between Central Pu blic Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Governme nt Department(s) / Organization(s) shall be taken by either party for its resolution through AMR CD.

- d. **ARBITRATION**: Any disputes pr differences where clause no. (c) is not applicable, the parties may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provided the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with reference to the v alue of the dispute and not the value of the contract which may be much higher. In all other ca ses, arbitration shall not be a method of dispute resolution arising out of this contract.
- e. **JURISDICTION**: If the matter is not resolved through above means, the dispute shall be resolv ed in civil court of law at Jharkhand only.
