

Pre Qualification Criteria- Ref. No.- UCIL/Civil-Mill/2024/DOP-28/01, Dated-12.02.2024

The eligible criteria to qualify in Techno commercial Part are as below:-

1. Average Annual financial turnover during the last 3(Three) consecutive financial years, ending 31.03.2022 shall be at least 30% (0.80 Lakhs) of the estimated cost supported by the audited annual accounts of each year.
2. Bidder shall have successfully completed similar works during last 7 (Seven) years ending on 31.03.2023 as per any one of following:
 - a) Three(3) similar completed works costing not less than the amount equal to 40% (1.07 lakhs) of the estimated cost
or
 - b) Two (2) similar completed works costing not less than the amount equal to 50% (1.33 lakhs) of the estimated cost
or
 - c) One (1) similar completed works costing not less than the amount equal to 80% (2.14 lakhs) of the estimated cost.

The corporation may request to the bidder to visit the proposed work site to well acquaint about the site work before filling the rate /submit the tender

3. Bidders must attach Work Order and work done certificate mentioned executed amount and date of completion.
4. Similar works means "Experience in Any type of Civil Construction work or Civil Maintenance work in Central / State Govt Organization / PSU / Public Listed Company."

1. Security Money Deposit:
Security money deposit equivalent to 10 (Ten) % of the ordered value is required to be deposited in accounts Department-UCIL in the form of demand draft before the start of the work. 100% security deposit will be refunded on written request in duplicate to the engineer –in- charge after expiry of defect liability period.
2. Completion Time:
15 (Fifteen) days (including Sunday & holiday) from the date of issue of work order/ commencement of work at site.
3. Payment Terms:
One (1) R.A and One (1) Final Bill will be paid against this work after submission of quadruplicate bill. Final bill should be submitted within 30 (Thirty) days from the date of completion.
4. Working period:
General Shift (excluding Sunday & holiday) as per direction of Engineer –in-charge. 07:00 AM to 12:00 Noon and 02:00 to 05:00 PM.
5. Rate:
The rate shall be quoted by the contractor must include all taxes (GST) & Duties, PF, PPE, Insurance, etc. No extra payment will be entertained after rate quoted by the contractor.
6. Minimum wages, EPF, Bonus, Insurance, Safety appliances and tools & tackles, contractor's profit should be included in quoted rate. No extra payment will be made thereafter.
7. Party has to submit hard copies of PAN Card, GSTIN, & EPF registration no. Contractor to execute contract agreement as per UCIL Account department on a stamp paper.
8. If any discrepancy found in figure & words of rate or amount of the price bid then rate or amount in words will be treated as final. Defect liability period –03 Months. Contractor has to take insurance for minimum 2 Nos of Workmen.
9. The Contractor shall at all times, take all reasonable precaution for the safety of employees, including those of sub-contractors in the performance of his contract and shall comply with all applicable provisions of both Central as well as the State Safety Laws. In addition to the Safety provision already included in the tender, the contractor will be sole responsible to ensure safety at work place and also to provide all PPE's to be provided by contractor to worker, no responsibility to UCIL.
10. Contractor shall have at least one person fully trained in first Aid present at the site of work all the time.
