The following are the Eligibility criteria for this **Non-divisible Works Contract**.

1. **PAST PERFORMANCE AND PROJECT / PAST EXPERIENCE etc. CRITERIA:**

Experience of 'The bidder' having successfully execution (completion) of ONE (01) number of similar type of contract of "hiring of vehicles- passenger transport commercial vehicles" to any Central / State Govt. Organization / PSU / Public Listed Company in last five (05) years ending on last date of the previous month in which BID issued.
