Evaluation will be done based on the documents submitted by the tenderers. No correspondence shall be made after opening of technical part regarding any missing document.

Only such firms need tender who can produce satisfactory evidence that they have the necessary experience & financial resources and organization to undertake such work as per criteria mentioned below.

i) The Tenderer's average annual turnover for the work during last 03 years, ending 31st March of the previous financial year, should be at least **30% of estimated value** i.e **Rs. 4.45 Lakhs** in Audited balance sheet & profit & loss account of each year must be submitted by the tenderer.

ii) Experience of having successfully completed **Hiring of Heavy vehicle like JCB/ Pay Loader /Poclain / Tipper** during last 07 years ending last day of month previous to the one in which application are invited should be either of the following:

a) One single similar completed job costing not less than 80% **of estimated value** i.e **Rs. 11.88 Lakhs.**

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
