1). ELIGIBILITY CRITERIA FOR THE BIDDERS

- 1. A firm determined non-performing/ debarred/ blacklisted by U.C.I.L. shall not be eligible to bid during the period so determined.
- 2. GEOGRAPHIC PRESENCE: Registered Office or at least one of the registered Branch Office of the bidder s hall be located and registered within the geographical limits of Jharkhand State (where the services need t o be provided).

Documentary evidence must be provided in the form of Municipality trade license or other such document s as per the following which satisfies as a proof of having the office establishment.

- i. Landline telephone bill (in the name of the firm)/ Electricity bill (in the name of the firm) of public & approved private operators in the state. (Bills not to be older than 4 months); or
- ii. Property ownership deed i.e. Title deeds of the property in the name of the firm duly stamped and regist ered; or
- iii. GSTIN Registration issued in the name of the firm; Or

A. In case of works having delivery period of within a year (24 months) contract shall be

concluded with firm and fixed price and is not subject to any escalation. However, only statutory v ariation limited to duties, taxes, revision of prices under Administrative Price Mechanism (APM) and minimum wages are considered for adjustment in contract price.

- **B.** However, for calculating escalation, the price prevailing on the date of opening of price bid shall be taken as base price.
- **C.** Escalation shall be calculated, based on notified fair wages and in the absence of which consu mer price index for labour would be applicable. Market rate for cement and steel, Government approved price of bitumen & POL, Whole sale price index for other materials shall also be taken into consideration as & when required.

- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1

- bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
