DISPUTE RESOLUTION MECHANISM AND JURISDICTION:

CONCILIATION:

Notwithstanding anything contained in this contract, any disputes or differences whatsoever, which are to be settled amicably between the parties with their authorized representatives, shall be resolved through concillation.

MEDIATION:

Any disputes or differences, which are not settled amicably through conciliation, then either of the parties, may approach for Mediation to settle under MediationAct, 2023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time AMRCD Any disputes or differences between the parties are not settled amicably with conciliation and/or Mediation, then such disputes or differences shall be resolved through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD).

Any disputes or differences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSES) / Port Trusts, inter-se and also between CPSE(S) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through A MRCD.

ARBITRATION:

(Ten Crores). This amount is with reference to the value of the dispute and not the value of the contract which may be much higher. JURISDICTION:

If the matter is not resolved through above means, the dispute shall be resolved in civil court of law at Jhar khand only.

JOB AREA-1 UNSKILLED MANPOWER -8 NOS

Sub: Outsourcing 6 nos. unskilled labours for 365 days -Engaging 02 nos. unskilled persons in any shift (i.e. in "A", "B" "C" & "G" shifts including Sunday & holiday) in chemical "B" section, Mill for 365 days To run (or assist in running) the Pyrolusite grinding mill and Lime Slaker in Reagent plant and washing of carbide sludge on requirement. To clean the spillage in Reagent plant (i.e. Pyrolusite and Lime spillage.), conveyor a rea of Slaker feeder belt and distributor belt (at the top of the Burnt lime bins) and Lime elevator area. Any type of work in Leaching section (Like sample collection in leaching, cleaning/draining of spillage of slurry in leaching Pachuca and tanks or Pachuca cleaning). Details of jobs for replacement of filter clothes:

The scope under this work involves cutting of nylon strings, removing of caulking rope, removing of old filte r clothes, fixing of new filter clothes, fixing nylon string, stringing of nylon string along with shifting of old & replaced filter clothes & nylon strings from jobs to allocation within the plant as per direction of the Engi neer-In- Charge or its representatives. Cleaning of spilled slurry around filters, cutting of nylon strings wrapped around repulper, filter trunion and their disposal.

Manpower is mandatory for all the 365 days, about 23 nos of unskilled manpower. Only For 3 paid holidays-- 26th jan,15th Aug & 2nd oct payment will be made and plus as per the ref letter no:UCIL/DGM(P &IRs)/GEN/2024 dt 07.09.24 (Inclusion of provision of leave with wages if applicable) .Safety appliances ,to ols & tackles a sample needs to be provided before providing to the manpower. Safety appliances which i ncludes new PPE and new tools & tackles needs to be supplied by the bidder only & it will be reimbursed o n submitting the documentary evidence. This is applicable only on the successful execution &completion o f work order.If the bidder didn't complete the work completely(1year), Safety appliances, tools & tackles c harges will not be reimbursed or deducted the entirely amount if paid at the during the work execution. Fr om the first day of work itself contractor needs to provide the new safety appliances, tools & tackles for all the manpower supplied for the mention work. After awarding the work order, a Person needs to be depute d by the contractor for supervision work and they need to be present in the site for 8 hours duty and looks after the safety and day to day activities of the supplied manpower and the deputed person service charge or payments will be in the scope of contractor only. Supervision work will be looked after by the bidder sup ervisor in the site for daily routine works 8 hours duty after awarding the work order. Manpower may be all otted in any shift with any timings. Manpower should report to the working place on time and they need to work in the site for 8 hours as per their shift duty. If required Manpower maybe called or posted in bulk i.e t otal manpower in any single shift. Manpower should have their weekly off once in every six working days. Manpower should not work in double or two shift continuously in a single day. Manpower should follow their r duty schedule and they should not work in the off day to makeup their absent duty (for eg: if the manpo wer is having their weekly off on sunday and if they were absent on wednesday ,to make up the Wednesd ay absent they should not to work on Sunday) Manpower needs to present in their entire duty hours and b iometrics punching should be followed for attendance (if available).

Necessary reliever/required manpower arrangement should be provided by the bidder to fulfill the shortfall of attendance.

- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>सामान्य नियम और शर्तें/General Terms and Conditions</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
