Only such firms need to tender who can produce satisfactory evidence that they have the necessary experience & financial resources to undertake such work as per criteria mentioned below.

i) Experience of having successfully completed SIMILAR WORK during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:

a) One similar completed works costing not less than the amount equal to Rs.4,69,337.00/-

Or

b) Two similar completed works each costing not less than the amount equal to Rs.2,93,336.00/-

Or

c) Three similar completed works each costing not less than the amount equal to Rs.2,34,668.00/-

“Similar work” means experience in Fabrication/Repairing work of Booms of underground Machine OR Fabrication job related with underground Machine. The bidder will have to submit copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate, from the client, as documentary evidence in support of their experience / credential, failing which offer may be summarily rejected.

The submitted Work Orders / LOI / LOA and Completion Certificates shall be either in English or Hindi only. Credentials other than English or Hindi language shall not be considered.

ii) Geographical Presence: Proof of having Registered Office and workshop located and registered within the districts of East Singhbhum/ West Singhbhum/ Saraikela & Kharaswa districts of the buyer i.e. Jharkhand where the services needed to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.
