In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 3. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or

3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

SCOPE OF WORK

The scope of this tender will be generally as per specification schedule of quantities and general / special c onditions of contract and as directed by Engineer in charge , on behalf of Corporation. However major cons truction work covered complete in all respect including finishing under this contract are as follows:

1. All the required materials, labour, tools and tackles, material transportation etc. All finishing are in the c ontractor's scope.

2. No extra required materials, labour, tools and tackles, material transportation etc not be provided by U CIL.

3. Cutting of grasses before starting the work cleaning in the working area and disposal with in 2.00 K.M. n o extra payment will be made for this.

4. The removal from the site of any material brought there on by the Contractor and the substitution of an y other material thereof. No extra payment will be made for this.

5. Schedule of items mentioned in Bill of Quantity or as per directions of Engineer-in-charge.

6. The scope of work also includes the following for which no extra payment will be made. Therefore, contr actor may consider this while quoting their rate of other items as mentioned under bill of quantities for various items of work.

Note: - Contractors are advised to see the area get acquainted with the actual features of the land where work is to be executed and get other related information before quoting their rates for carrying out the work successfully.

TECHNICAL SPECIFICATION

1. All work for civil items shall be carried out as per latest Indian standard, CPWD/ISI and MOST specification n which shall form part of this specification and instruction of the Engineer in Charge in case of conflict or where an aspect of work is not covered by the Indian Standard and specification Engineers instruction shall be strictly followed.

2. All the fine and coarse aggregate shall conform to latest IS-383/MOST specification.

<u>The Pre- qualification criteria (PQC) to qualify in Techno commercial Part are as</u> <u>below</u>:-

- 1. The Bidder must have experience in similar nature of works in **last seven years** ending last day of month previous to the one in which applications are invited should be either of the following:
 - a) One similar nature of work not less than 80 % of the estimated value of the work .
 - Or
 - b) Two similar nature of work not less than 50 % of the estimated value of the work .
 - Or
 - c) Three similar nature of work not less than 40 % of the estimated value of the work .
- Minimum average annual financial turnover 30 % of the estimated value of the work for last 03(three) financial years and submission of duly audited copy of Profit & Loss account statement and Balance Sheet of financial years 2021-22, 2022-23 & 2023-24 by Chartered Accountant.

3. The Bidder shall furnish a copy of MSME/NSIC, ESIC, GST, PF Registration Nu mber, ESIC and Make in India (MII) compliance documents.

4. Bidder must submit **Work Order and Work done or Work Completion Certific ate** mentioned executed amount and date of completion in **last seven years** endin g last day of month.

5. Similar Works means:- "Experience in execution of work with any Central/ State Govt. Organization / PSU/ Public Listed Company for any Civil Constr uction / Construction of Toilet and Jal Minar."

6. Geological Presence:-

The bidder participating in the bid must have the **Head Office or a Branch Office in the East Singhbh um district in the State of Jharkhand**. Any document issued by Govt. of India or Govt. Authority of Jhar khand shall be considered.

Documentary evidence must be provided for proof of having the office establishment in East Singhbhum Di strict in the State of Jharkhand are mentioned below:-

A) Trade License issued by Govt. Authority of Jharkhand etc or

B) GSTIN registration or

C) Udyam /MSME /Udyog Aadhaar certificate.

Without submission of the above documents for Office address in the East S inghbhum, then the tenderer will be disqualified in Techno Commercial bid.

7. Relaxation of conditions of prior turnover :

Pre-qualification criteria with respect to Prior Turnover may relax for all MSEs and Start-ups [Whether Micro & Small Enterprises or Otherwise] as per GOI guidelines subject to meeting of Quality and Technical specifications. UCIL may consider allowing the participation of "Start up" companies with capability to execute the **supply/services**, as per technical specifications/ perform the job as per sc ope of work specified in the tender and subject to meeting extant & relevant guidelines of Government of I ndia. This should be confirmed and substantiated in the technical bid. **The bidder who intends to partic ipate as "Start-up" company should enclose the Certificate of Recognition issued by Departme nt of Industrial Policy and Promotion, Ministry of Commerce & Industry, Govt. of India during s ubmission of Technical bid.** (AS DEFINED IN GAZETTE NOTIFICATION NO. D.L-33004/99 DATED 18.02.20 16 AND 23.05.2017 OF MINISTRY OF COMMERCE AND INDUSTRY), AS AMENDMED TIME TO TIME).

Note: - The bidders seeking relaxation for prior turnover must enclose the certificate over th e relevant criteria as mentioned in PQC of the bid, otherwise the bidder will not be considered for exemption. The bidder shall submit documentary evidence such as original DD/SBI Collect C hallan (UCIL Copy), Hard copy of Uploaded Document like PQC, NSIC/MSME, and EMD shall be s ubmitted on or before the due date and time in the O/o. D.G. M. (Pers & IRs).

8. **The tender documents shall be issued free of cost** to company/units registered with MSME/Nation al Small Industries Corporation/Director of Industries of State, Cottage Industries approved by the State Au thority or any other entity as may be specified by Govt. guidelines from time to time, after ensuring that t he approval pertains to the class of item/works for which tender is floated.

Benefit for MSME owned by SC/ST will be applicable as per the Govt. guide lines. In case of Government un dertaking / PSU, tender documents may be issued free of cost subject to approval of Competent Authority and it shall be mentioned in the tender document.

The tenders are to be uploaded at UCIL e-proc <u>http://ucil.gov.in/</u> and <u>http://bidplus.gem.gov.in</u> on or befor e due date fixed for receiving the bid. Physical submission of tender shall not be accepted.

Tenderers registered with National Small Industries Corporation (NSIC)/Small Scale Industries (SSI)/Micro S mall & Medium Enterprises (MSME), for the tendered work will be exempted for submission of EM D and Tender Fee.

Offers will be opened on due date as mentioned above by the Corporation's authorized representative(s) i

n the presence of Tenderers who are present.

Tenders received without earnest money are likely to be rejected. Tenderer shall enclose the EMD in form of DD/Bank Draft/BG in separate envelope and shall enclose the same in the envelope containing technical proposal.

The Corporation reserves the right to accept or reject any or all the tenders in full or part and the tenderer s shall be bound to perform the same at his quoted rates.

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
