1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. 3. GEOGRAPHIC PRESENCE:

Office registration certificate: Registered Office within the geographical limits of Jha rkhand state where the services need to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as p er the following which satisfies as a proof of having the office establishment. Party should have Boiler repair License / Certificate issued by Jharkhand authority in the name of the Firm.

- 4. EPF registration copy, GSTIN copy, PAN copy must be submitted along wi th the bid.
- 5. Any bid not complying PQC requirements shall be summarily rejected.

The eligibility is to be decided strictly based on documents submitte d at the time of receipt of tenders. No additional documents are to be allowed to be submitted after receipt of tenders but there is no bar to seek clarification or authentication of submitted documents. Scope of Work

Subject: Repairing of boiler Capacity-5000kg/hr., Make- Walchandnaga d Industries Ltd., at UCIL Jaduguda.

Repair work for Package Boiler Make – Walchandnager Industries Ltd. Capacity-5000k g/hr., permissible working pressure -10.9Kg/cm2, total heating surface area=144.0m 2.The UCIL operating and inspection engineers, after inspection with Boiler Inspector Jamshedpur area, have establish the nature and amount of repair required to return the boiler to normal operation. All repair work in pressure part should have the approv

al of the **concerned (IBR) statutory authorities**. After the approval, pressure part repair work has to undertake only with qualified welder. The drawings and design doc uments should be referred to confirm the material of construction, tube sizes and ed ge preparation etc. before start of the repair work. The approved contractor has to carry out following repair work to boiler with certification as follows:

1. Contractor will make all the drawings required for the fabrication of the tub e replacement, repair or replacement of parts as per requirement and ge t all the drawings approved from CIB, Jharkhand. Approval of all work from CIB Jharkhand will be in party scope.

DRAWINGS: As appropriate, drawings shall be prepared to describe the repair. Drawings shall include sufficient information to satisfactorily perform the repair. Following review and certification, the repair plan shall be submitted for acceptance to the Authorized Inspection Agency/CIB Iharkhand and make the acceptance inspection and sign.

- 2. Replacement of all corroded/Thinned and leaky smoke tubes of boiler includ ing the cutting, removing, ramming, grinding, expanding and welding of tubes as per IBR.
- a) Supply of carbon steel tube **Specification's BS3059 GR.320 ERW, IBR Certifie d, OD=65.0 mm X 5.16 WALL Thickness, of two different lengths = 5.7 m and 5m.**
- b) Tube should be as per **BS-3059 pt-1 Gr.320** and make: Tata/SAIL only are acceptable with certificate in form IV A.
- c) Drilling of boiler plate by only manual clamping and cutter method is used for removing old welding of boiler tube.
- d) Welding, grinding, ramming of all oval shape tube holes.
- e) Cleaning of tubes ends to bright metal, inside and outside for at least 40mm from we ld area and removing of all deposits of oxide, boiler water salts and slags to avoid gas and slag inclusions in the weld.
- f) Cutting of new tubes in proper size and annealing of both end of tube. (Important: p rojection of tube from tube sheet is max. 3.5mm)
- g) V making in all holes of tube by high speed cutting tools. (Important: depth of v-g roove for tube sheet is 6mm to 3.5mm)
- h) Fitting, expanding of both ends of tube in boiler plate.
- i) Tubes should be butt welded by fusion welding and these tested hydraulically at discr etion of the Boiler Inspector.
- j) Tubes to be seal welded provided the ends of the tubes have sufficient wall thickness to prevent burn through. Seal welding shall be applied with a maximum of three light layers in lieu of one or two heavy layers. Sea I welding shall not be considered a strength weld.
- k) During fabrication of the tubes, contractor will arrange the inspection of the tubes by the CIB, Jharkhand before fitting, if required so.
- I) You will carry-out all the allied jobs related to the retubing of the boiler, like chemical cleaning & hydro test etc.
- m) Total nos. of tubes to be replaced in second pass of boiler of size OD 65.0mm \times 5.16 mm wall thk. \times 5.7m length = **60nos**.

n) Total nos. of tubes to be replaced in first pass of boiler of size OD 65.0 mm x 5.16 mm wall thk. X 5.0m length= 64**nos.**

Unit of Measurement (UOM) = no. of tubes basis.

- 3. Replacement of damaged man-hole sheet along with its flange as per guidel ines of repair method by IBR. (02 Nos)
- a) Supply of carbon steel plate Specification's **ASTM A516 GR70 OR IS: 2041/ IS: 2100. IBR Certified, thickness = 16mm. Size=1600mm x 500mm.**
- b) Preparation of sheet by edge preparation.
- c) A bulge on a plate shall be investigated to determine the extent of damage to the pla te prior to repair.
- d) The defective material to be removed until sound material is reached.
- e) The patch should be rolled or pressed to the proper shape or curvature. The edges should align without overlap.
- f) Welding of new sheet as per specified welding method.
- g) Performing all other related work required to carry out the work described above, but not specifically listed;

Unit of Measurement (UOM) = lump-sum basis

- 4. <u>Chemical & mechanical Cleaning of boiler:</u> method of removing hydroxyapatite and other phosphate scales from boilers, and other equipment, comprising the st eps of:
- (a) Soaking the scale in an inhibited solution of from about **0.1% to about 10%** sulphu ric acid to thereby form a sulphate;
- (b) Treating the sulphate formed by the action of the sulphuric acid on the scale wit h a solution selected from the group consisting of water soluble hydroxides (So dium Hydroxide),
- (c) Soaking the product formed by the previous step with an inhibited solution of about **5% to about 15%** hydrochloric acid, thereby forming a water soluble salt of sai d hydrochloric acid & followed by solution of tri-sodium phosphate.

a) Supply of safety valve as per IBR,CS-300, Flange Type

6. FEUSIBLE PLUG (04 Nos)

a) Feusible Plug, 25mm, Bronze, Neta Make, Ibr, 2setd Desing

7. Replacement of Damaged/Thinned and leaky Boiler Shell Inner Plate With Heat Chamber Plate

a) Replacement of Damaged/Thinned and leaky Boiler Shell Inner Plate With Heat Chamber Plate-IBR, BQ, Carbon Steel, IBR-16MM, With Ring Stripier, Including the cutting, Removing, Ramming, Gr

8. Renewal of licence (3 Set)

a) Renewal of licence with necessary Obligation & Necessary Maintenance (Gauge Glass Mabrey Set, Main Stop Valve, Blow Down Valve, Safety Valves, Feasible plug Etc.)

9. Refectory Material -Fire Crete Super 1200 °C (200 Kg)

- 10. Contractor will arrange suitable quantity of **20-30% concentrated hydrochloric a cid & inhibited solution** with arrangement for tool & tackles for chemical and m echanical cleaning of boiler for both fire and water side along with circulation pum p & suitable length hose & control valve.
- 11. All repair work shall be carried out under the supervision/guidance of Boiler Inspector and all repair should be satisfy the Boiler Inspector.
- 12. The electric arc or oxy-acetylene welding sets and all other tools in contractor posse ssion for carrying out repair are suitable for the work undertaken.
- 13. All tools -tackles and consumable items unless specifically mentioned in UCIL scope-like **DC welding set (Rectifier)** with adequate cable length suitable for working in boiler, electrode, DA & Oxygen etc. are in contractor scope.

14. Welding electrode specification: E7018- H8. (2.5mm & 3.15mm)

- 15. The quality of material used conforms to the specifications that are prescribed.
- 16. Welders employed by him possess certificate issued as required under Chapter XIII of these regulation.

17. Welding method:

- a) The minimum preheat temperature for welding shall be 350°F (175°C) and the maxim um interpass temperature shall be 450°F (230°C); The preheat temperature shall be checked to assure that 4 in. (100 mm) of the material or four times the material thickness (whichever is greater) on each side of the groove (or full thickness of joint for a groove weld) is maintained at the minimum temperature during welding. When the weld does not penetrate through the full thickness of the material, the minimum preheat and maximum interpass temperature need only be maintained for 4 in. (100 mm) or four times the depth of the repair weld (whichever is greater) on each side of the joint.
- b) The welding technique shall be a controlled-deposition temper bead technique and sh all include a buttering layer deposited over the entire groove faces (or fillet leg fa ces) using a 3/32 in. (2.5 mm) diameter electrode. The buttering layer shall be deposited

- using stringer beads with an overlap of approximately 50%. The second and remaining layers shall be deposited over the buttering layer using a 3/32 in. (2.5 mm) or 1/8 in. (3 mm) diameter electrode for SMAW.
- c) After completion of welding and without allowing the weldment to cool below the mini mum preheat temperature, the temperature of the weldment shall be raised to a t emperature of 450°F (230°C) minimum for a minimum period of two hours. This h ydrogen bake-out treatment may be omitted provided the electrode used is classified by the filler metal specification with an optional supplemental diffusible e-hydrogen designator of H4 (e.g., E7018-H4).
- d) After the finished repair weld has cooled to ambient temperature, the final temper be ad reinforcement layer shall be removed substantially flush with the surface of the base material.
- 18. Standard of work should be of high order and comply with all the requirements and t est may prescribed by Chief Inspector/Boiler Inspector.
- 19. Disposal off site of all components removed in accordance with environmental stand ards and clean-up of the site during and after the work.

20. <u>Liquid penetration test:</u>

- a) A pressure test as required by the original code of construction shall be conducted. The test pressure shall not exceed **150% of the maximum allowable working pressure (MAWP)** stamped on the pressure-retaining item, as adjusted for temperature. When the original test pressure included consideration of corrosion allowance, the test pressure may be further adjusted based on the remaining corrosion allowance. The pressure test for replacement parts may be performed at the point of manufacture or point of installation.
- b) Hold-time for the pressure test shall be **a minimum of 10 minutes** prior to examina tion by the Inspector. The test pressure shall be reduced to the MAWP for close ex amination by the Inspector. Hold-time for close examination shall be as necessary for the Inspector to conduct the examination.

21. <u>Utility supply by UCIL (Power, Water, Steam, Air only)</u>

- a) Responsibility of UCIL will be of providing 3 phase /single phase power at one point. The contractor has to make his own arrangement to use the same at work site by extending cables etc. as per requirement.
- b) Service air, service water and steam shall be provided to be the contractor free of cost at one point. The contractor has to make his own arrangement to use the same at work site by extending pipelines, etc. as per requirement.
- c) UCIL will provide necessary amount of sulphuric acid, tri-sodium phosphate and sodium hydroxide for chemical cleaning on condition of availability.
- 22. **Completion time:** The work shall be executed strictly as per time Schedule gi ven in Tender Document. The period of completion given includes the time r equired for mobilization as well as Testing, rectifications, if any, re-testing an d completion in all respects to the entire satisfaction of the Engineer-in-Char ge.

Bidders have to quote rate on GeM portal including GST applicable as on bid due date. The Contract Sum is the "price inclusive GST", i.e. inclusive of GST of quoted value and all taxe s & duties and all other statutory levies applicable, including costs and expenses which may be required in and for the supply, scope of work and completion of the work described, together with all general risks, liabilities and obligations set forth or implied in the docume nt upon which the tender is based.

- (vi). The successful Tenderer fails to submit the Performance Guarantee (Security Deposit) within the period specified, if applicable.
- (vii). The Tenderer does not accept the correction of the Bid Price, by submission of updated bid.

The EMD/ Bid Security of the successful Tenderer to whom the contract is awarded will be r eturned or adjusted into Security Deposit (SD) after the said Tenderer provides the Contract Performance Guarantee/ Security Deposit (SD) and signs the Contract Agreement.

If the successful Tenderer fails to submit Contract Performance Guarantee/ Security Deposi t (SD)as specified within 30 (thirty) days after the date of issue of Letter of Award of Contract, or fails to sign the contract agreement then the EMD/ Bid Security amount will be forfeit ed by the Corporation, without any notice or proof of damages etc.

3. Validity of Tender: -

Bids shall be kept valid for period specified in GeM Portal from the final Due date of submis sion of bid'. A Bid valid for a shorter period may be rejected by UCIL as 'nonresponsive'. The Tenderers shall not be allowed to increase, amend or withdraw his tender within this period and if he do es so the earnest money deposit and security deposit may be forfeited.

If required, the Corporation may request the Tenderer to extend the "bid validity period". The request a nd responses thereto shall be made in writing or through GeM portal, if a tenderer accepts to extend the period of validity of bid. The tenderer accepting such request shall not modify their bid on their own. A Tenderer may refuse the request to extend the bid validity period without forfeiture of his EMD.

4. Deviation: -

ZERO DEVIATION: Deviation to terms and conditions of "Bidding Documents" may lead to rejection of bid. UCIL will accept bids based on terms & conditions of "Bidding Documents" only. Bidder may note UCIL will determine the substantial responsiveness of each bid to the Bidding Documents. For purpose of this, a substantially responsive bid is one which conforms to all terms and conditions of the Bidding Documents without deviations or reservations. UCIL's determination of a bid's responsiveness is based on the content of the bid itself without recourse to extrinsic evidence. UCIL reserves the right to raise technical and/or commercial query(s), if required, may be raised on the bidder(s). The response(s) to the same shall be in writing, and no change in the price(s) or substance of the bids shall be sought, offered or per mitted. The substance of the bid includes but not limited to prices,

5. Award of Contract:-

The Corporation will award the Contract to the successful Tenderer, whose bid/updated bid has been de termined to be substantially responsive and to be the lowest evaluated bid, provided that the Tenderer is determined to be qualified to perform the Contract satisfactorily.

6. Privilege Clause:

The Corporation reserves the right to accept or reject any Tender, and to cancel the Tender process and reject all Tenders, at any time prior to the award of Contract, without thereby incurring any liability to the affected Tenderer or Tenderers or any obligation to inform the affected Tenderer or Tenderers of the grounds for the Corporation's action..

7. SECURITY DEPOSIT (SD):

Total amount of Security deposit shall be limited to **10** % of the awarded value of work. Fifty percent of this amount shall have to be deposited as initial security deposit at the time of execution of agreement including the amount deposited as Earnest Money.

- a) Acceptable mode of payment of Initial Security Deposit/ Earnest Money:
 - (i). For deposit upto Rs. 5,000/-: Demand Draft payable at SBI, Jaduguda/ Hartopa.
 - (ii). For deposit beyond Rs. 5,000/- and up to Rs. 1.00 Lakh.: DAC/TDR/FDR etc. from any Schedul e Banks duly pledged in favour of UCIL. But in case of Earnest Money of amount more than Rs. 50,000/-, the Tenderer should submit Bank Guarantee issued by Nationalized bank as mentioned in Para 9(a) (iii).
 - (iii). For deposit beyond Rs. 1.00 Lakhs: Bank Guarantee issued by Scheduled bank of jointly, sev erally bound with the Contractor to the purchaser for the amount same above. The terms of the said guarantee shall be such as shall be approved by the purchaser and the obtaining of such guarantee and the cost of guarantee to be so entered shall be at the expenses, in all respects, of the Contractor. The said guarantee shall be valid till the expiry of the defect liability period and issue of the final certificate by the Engineer, and with a claim period of Six months beyond it's required validity.

- (iv). In addition to the above, **if contractor failed to submit the security deposit, S.D. va lue of the work will be deducted from the 1****I / **subsequent Running Account bills b y way of percentage deductions. Such percentage deduction shall be @ 10 % of the running account bills till the full amount of security deposit is realized/ retained by the Corporation.
- b) All compensation or other sums of money payable by the Contractor under the terms of this contact or any other contact or any other account whatsoever may be deducted from or paid by sale of a s ufficient part of his security deposit or from the interest arising there from or from any sums which may be due or become due to the Contractor by the Corporation or any account whatsoever and i n the event of his security deposit be reduced by reason of any such deduction or sale as aforesaid, the Contractor shall within fourteen days of receipt of notice of demand from the Engine er-in-charge make good the deficit.

c) REFUND OF SECURITY DEPOSIT:

Security Deposit (SD) shall be refunded to the Contractor on the Engineer-in-charge certifying in w riting that the work has been completed as per condition Penalty (Liquidated Damage clauses hereof etc. Against submission of a Performance Bank Guarantee (PBG) for 10 % of the w ork order value

Or You will be given the option to convert SD BG in to PBG and on expiry of the Defects liability per iod (referred to in condition **Penalty (Liquidated Damage clauses**) hereof) or after payment of the Final bill payable whichever is later, the Engineer-in-charge shall on request from the Contractor refund to him the security deposit provided the Engineer-in-charge is satisfied that there is no demand outstanding against the Contractor.

8. FORFEITURE OF SD:

The SD shall stand forfeited in favour of UCIL, without any further notice to the contractor in the following circumstances:

- o In case of any failure whatsoever on the part of the contractor at any time during perform ance of his part of the contract including the extended periods of contract, where notice is given and time for rectification allowed.
- o If the contractor indulges at any time in any subletting/ sub-contracting of any portion of the work without approval of UCIL.

9. Contract Agreement:-

Contract Agreement should be executed in prescribed format on a non-judicial stamped paper within 3 0 (thirty) *days* from the date of issue of work order / L.O.I. However, no payment will be made without e xecution of contract agreement.

Within 30 days of issue of LOI, the successful Tenderer shall sign and date the contract and return it to the Corporation. Till the contract is signed, the LOI issued to the successful Tenderer shall remain binding amongst the two parties.

In the event of failure on the part of the successful Tenderer to sign the contract within the period specified above or any other time period specified by Corporation, UCIL reserves the right to terminate the L OI issued to the successful Tenderer and invokes the Bid Security or the Performance Security if submitt ed by the successful Tenderer/ action as per declaration for Bid Security.

10. Payment Terms:

Payment will be released after satisfactory completion of the work or event (in case of continuous supply of services) in all respect and certification by the Engineer In charge, UCIL within 30 days of <u>submission of tax invoices(s) in original + duplicate 2 (two) copies</u> as prescribed under rule 1 of invoices rules. Contractor shall issue tax invoice (s) after the provision of service within 30 days from the date of certification of work or event, & also mention work order no., date as well as name of work and actual date of commencement of work or event, showing the description, value, tax charges thereon and such other particulars as prescribed as per GST Act, 2017 invoice rule in their every invoice(s). Final bill will be released only after submission of Labour Report / Annual Return (in prescribed format) (in the month of January & after completion of whole work) and work completion (after completion of all obligations under the co

ntract) letter in duplicate by the contractor.

11. Tax & Duties: -

The Contractor shall:

- (a) Pay and indemnify the Corporation against all taxes, duties, goods and services tax and duties, charges, taxes payable in connection with the carrying out of Work under Contract; and
- (b) Provide all security required under any statutory requirement as security for the payment of any d uties, charges, and taxes.

12. INCOME TAX & STATUTORY LEVIES:

Income Tax at the prevailing rate as applicable from time-to-time shall be deducted from CONTRACTOR's bills as per Income Tax and quoted rates shall be deemed to include this. As regards the Income Tax, surcharge on Income Tax or any other Corporate Tax or Statutory levy payable by the Tenderer for reason of the Contract awarded, then Corporation shall not bear any tax liability whatsoever, irrespective of the mode of construction of contract. The Tenderer both Indian and/or foreign shall be liable and responsible for payment of such tax, if attracted under the provision of Law of Land.

13. Insurance:-

The contractor shall ensure & maintain insurance against his liability for accident or injury to workmen or machineries used for the work and shall submit 2 (two) copies of the policy & receipt (s) of premiums paid or satisfactory evidence of insurance coverage at their own cost valid for whole contract period at a time for all the persons to be engaged to the Engineer-In -charge, UCIL before the commencement of work. Contractor shall also submit the proof of renewal of the same policy at least 2 (two) days before the expiry date of the previous policy to the Engineer-In-charge, UCIL. The contractor will not be allowed to carry out any activity without necessary insurance coverage (mentioning working height depend upon the job requirements and as per insurance rules) of their persons. Insurance policy shall also indemnify UCIL against any claim raised by the injured / affected workmen or his family.

14. Indemnity: -

Contractor will fully indemnify the corporation against all responsibility, any costs or expenses (includin g legal costs on an indemnity basis) and Claims of contractor's workmen in respect of personal injury or death or loss of, or damage to or interference with, any other property (whether real or personal), third party or to corporations' personnel and properties. Contractor shall abide by all the necessary pro visions of various other Labour Laws/Acts viz. ESI/Bonus, Workmen's Compensation, EPF and any other laws and rules applicable, in this regard. If on account of non-compliance with the provisions of any laws, Corporation is called upon to make any payment to or in respect of his employees, the service provider shall fully reimburse to Corporation for all such payment and Corporation shall be free to make deductions on this account from the amount of P erformance Security Deposit and retention money.

15. Penalty (Liquidated Damage): -

- (a) Liquidated Damages (LD) shall be levied where reasons are attributable to supplier / contractors for delays in execution of purchase order/ contract. LD shall be levied @0.5% per week or part there of on the value of unfinished supply/work order for each week of delay subject to a maximum of 5% of the total value of contract (excluding Taxes and Duties). LD is liable to GST at applicable rat
- (b) For the portion of delay which is attributable to UCIL / force majeure or to the supplier / contractor, the case shall be dealt with as follows :

(i) Delay attributable to UCIL / Force majeure:

Taxes & Duties	Any increase in taxes and duties on account of statutory increas e, fresh imposition of any duty or taxes which take place during such extended period shall be admissible.

(ii) Delay attributable to Supplier / Contractor:

LD	Applicable
Taxes & Duties	Increase / fresh imposition of taxes and duties during the extend ed period will be to the account of the supplier/contractor. Any decrease in taxes and duties during the extended period wil I be availed by UCIL
Price Variation	Price variation, if indicated in the contract will be applicable for the work performed within the scheduled period of contract. For work executed during the extended delivery period, the rates as prevailing on the last day of the scheduled contract period only may be paid. De-escalation/reduction, if any, which takes place, shall have to be passed on to UCIL

(c) The payment of liquidated damages shall not relieve the Contractor from its obligation t o complete the Works.

16. Variation in Price:

Unless the <u>Clause Price Adjustment</u> provides otherwisethe rates and prices quoted by the Tenderer s hall be fixed for the duration of the Contract and shall not be subject to adjustment or any account.

17. Termination for Insolvency:

The Corporation may at any time terminate the Contract by giving written notice of four weeks to the C ontractor, without any compensation to the Contractor, if the Contractor becomes bankrupt or otherwis e insolvent.

18. <u>Defaults, Breaches, Termination, and closure of Contract</u>

1) Termination due to Breach, Default, and Insolvency

a) Defaults and Breach of Contract

In case the contractor undergoes insolvency or receivership; neglects or defaults, or expresses inab ility or disinclination to honour his obligations relating to the performance of the contract or ethical standards or any other obligation that substantively affects the Procuring Entity's rights and benefit s under the contract, it shall be treated as a breach of Contract. Such defaults could include inter-ali a:

- i) **Default in Performance and Obligations:** if the contractor fails to deliver any or all of the Serv ices or fails to perform any other contractual obligations (including Code of Integrity or obligation to maintain eligibility and Qualifications based on which contract was awarded) within the period sti pulated in the contract or within any extension thereof granted by the Procuring Entity.
 - **ii) Insolvency:** If the contractor being an individual or if a firm, any partner thereof, shall at any time, be adjudged insolvent or shall have a receiving order or order for the administration of hi

s estate made against him or shall take any proceeding for composition under any Insolvency Act for the time being in force or make any conveyance or assignment of his effects or enter in to any assignment or composition with his creditors or suspend payment or if the firm be dissolved under the Partnership Act, or

iii) Liquidation: if the contractor is a company being wound up voluntarily, or by order of a Cour t or a Receiver, Liquidator or Manager on behalf of the Debenture-holders is appointed, or circu mstances shall have arisen which entitle the Court or Debenture- holders to appoint a Receiver , Liquidator or Manager.

b) Notice for Default:

As soon as a breach of contract is noticed, a show-cause 'Notice of Default' shall be issued to the contractor, giving two weeks' notice, reserving the right to invoke contractual remedies. After such a show-cause notice, all payments to the contractor would be temporarily withheld to safeguar dineeded recoveries that may become due on invoking contractual remedies.

c) Terminations for Default

- i) Notice for Termination for Default: In the event of unsatisfactory resolution of 'Notice of Default ' within two weeks of its issue as per sub-clause above, the Procuring Entity, if so decided, shal I by written Notice of Termination for Default sent to the contractor, terminate the contract in whole or in part, without compensation to the contractor.
- ii) Such termination shall not prejudice or affect the rights and remedies, including under sub-cla use below, which have accrued and/ or shall accrue to the Procuring Entity after that.
- iii) Unless otherwise instructed by the Procuring Entity, the contractor shall continue to perform the contract to the extent not terminated.
- iv) All Defect Liability obligations, if any, shall continue to survive despite the termination.

d) Contractual Remedies for Breaches/ Defaults or Termination for Default

If there is an unsatisfactory resolution within this period, the Procuring Entity shall take one; or m ore of the following contractual remedies.

- i. Temporary withhold payments due to the contractor till recoveries due to invocation of other contractual remedies are complete.
- ii. Call back any loaned property or advances of payment, if any, with a levy of interest at the prevailing rate (MIBID Mumbai Interbank Bid Rate).
- iii. Recover liquidated damages and invoke denial clause for delays.
- iv. Encash and/ or Forfeit performance or other contractual securities.
- v. Prefer claims against insurances, if any.
- vi. Terminate Contract for default, fully or partially including its right for Risk-and-Cost Procure ment as per following sub-clause.
- vii. Risk and Cost Procurement In addition to termination for default, the Procuring Entity s hall be entitled, and it shall be lawful on his part, to procure Services similar to those termin ated, with such terms and conditions and in such manner as it deems fit at the "Risk and Cost" of the contractor. Such Risk and Cost Procurement must be contracted within six months f rom the breach of Contract. The contractor shall be liable for any loss which the Procuring Entity may sustain on that account provided the procurement, or, if there is an agreement to p rocure, such agreement is made. The contractor shall not be entitled to any gain on such procurement, and the manner and method of such procurement shall be in the entire discretion.

n of the Procuring Entity. It shall not be necessary for the Procuring Entity to notify the contractor of such procurement. It shall, however, be at the discretion of the Procuring Entity to c ollect or not the security deposit from the firm/ firms on whom the contract is placed at the ri sk and cost of the defaulted firm.

Note: Regarding the Services that are not readily available in the market and where procurement difficulties are experienced, the period for making risk procurement shall be nine months instead of six months provided above.

viii. Initiate proceedings in a court of law for the transgression of a law, tort, and loss, not addre ssable by the above means.

e) Limitation of Liability

Except in cases of criminal negligence or wilful misconduct, the aggregate liability of the contract or to the Procuring Entity, whether under the contract, in tort or otherwise, shall not exceed the t otal Contract Price, provided that this limitation shall not apply to the cost of repairing or replacin g defective equipment, or to any obligation of the contractor to indemnify the Procuring Entity concerning IPR infringement.

2) Termination for Default/ Convenience of Procuring Entity and Frustration

a) Notice for Determination of Contract

- i) The Procuring Entity reserves the right to terminate the contract, in whole or in part for its (the Procuring Entity's) convenience or frustration of Contract as per sub-clause below, by serving written 'Notice for Determination of Contract' on the contractor at any time during the currenc y of the contract. The notice shall specify that the termination is for the convenience of the Pro curing Entity or the frustration of the contract. The notice shall also indicate inter-alia, the ext ent to which the contractor's performance under the contract is terminated, and the date with effect from which such termination shall become effective.
- ii) Such termination shall not prejudice or affect the rights and remedies accrued and/ or shall acc rue after that to the Parties.
- iii) Unless otherwise instructed by the Procuring Entity, the contractor shall continue to perform the contract to the extent not terminated.
- iv) All Defect Liability obligations, if any, shall continue to survive despite the termination.
- v) The Services and incidental goods/ works that can be delivered or performed within thirty days after the contractor's receipt of the notice of termination shall be accepted by the Procuring E ntity as per the contract terms. For the remaining Services and incidental goods/ works, the Pr ocuring

Entity may decide:

- a) To get any portion of the balance completed and delivered at the contract terms, condition s, and prices; and/ or
- b) To cancel the remaining portion of the Services and incidental goods/ works and compensat e the contractor by paying an agreed amount for the cost incurred by the contractor, if any , towards the remaining portion of the Services and incidental goods/ works.

b) Frustration of Contract

a) Notice of Frustration Event: Upon a supervening cause occurring after the effective date of the contract, including a change in law, beyond the control of either party whether as a result

of the Force Majeure clause or within the scope of section 56 of the Indian Contract Act, 1872, that makes it impossible to perform the contract within a reasonable timeframe, the affected p arty shall give a 'Notice of Frustration Event' to the other party giving justification. The parties shall use reasonable efforts to agree to amend the contract, as may be necessary to complete its performance. However, if the parties cannot reach a mutual agreement within 60 days of the initial notice, the Procuring Entity shall issue a 'Notice for Determining the contract' and terminate the contract due to its frustration as in the sub-clause above.

- b) However, the following shall not be considered as such a supervening cause
- c) Lack of commercial feasibility or viability or profitability or availability of funds
- d) If caused by either party's breach of its obligations under this Contract or failure to act in good faith or use commercially reasonable due diligence to prevent such an event.

3) Closure of Contract

The contract shall stand closed upon

- a) Successful performance of all obligations by both parties, including completion of Defect Liabilityo bligations and final payment.
- b) Termination and settlements after that, if any, as per **Termination due to Breach, Default, an d Insolvency or Termination for Default/ Convenience of Procuring Entity and Frustration.**
- **19. Statutory Variation Clause:** Unless otherwise stated in the contract, statutory increase in applicable GST rate only during the original delivery period shall be to Procuring Entity's account. Any increase in t he rates of GST beyond the original completion date during the extended delivery period shall be borne by the contractor. The benefit of any reduction in GST rate must be passed on to the Procuring Entity d uring the original and extended delivery period. However, GST rate amendments shall be considered fo r quoted HSN code only, against documentary evidence, provided such an increase of GST rates takes p lace after the last date of bid submission.

20. Time for Delivery of services and Extensions Thereof

The time and uninterrupted delivery of Services shall be deemed to be the essence of the contract. Subject to any requirement in the contract as to the completion of any portions or portions of the Services before completion of the whole; the contractor shall fully and finally complete the whole of the services comprised in the contract as per the Delivery and Completion Schedule stipulated in Format 1.1: Description of Services. If at any time during the currency of the contract, the contractor encounters conditions hindering the timely performance of services, the contractor shall promptly inform the Procuring Entity in writing about the same and its likely duration. He must make a request to the Procuring Entity for an extension of the delivery schedule. On receiving the contractor's communication, the Procuring Entity shall examine the situation and, at its discretion, may agree to extend the completion schedule, with or without liquidated damages and with and without denial clause by issuing an amendment to the contract in terms of the following clauses.

20.1. Extension Due to Modification

The Contract Manager might grant a reasonable extension of the completion date if any modificat ions ordered materially increase the time for delivery of the services. The contractor shall be responsible for requesting such extension of the date as soon as the cause thereof shall arise and in a ny case not less than one month before the expiry of the date fixed for completion of the services

20.2. Extension for Delay Not Due to Contractor

If in the opinion of the contractor, the progress of Services has any time been delayed due to follo wing reasons, then within 15 days of such happening causing delay, he shall give notice thereof in writing to the Contract Manager, but shall nevertheless do due diligence to bring down or make good the delays and to proceed with the services:

(a) any act or neglect of other contractor employed by the Procuring Entity or in executing the w ork/service not forming part of the contract but on which Contractor's performance necessarily depends or

- (b) proceeding taken or threatened by or dispute with external third parties arising otherwise that n from the contractor's own default etc. or
- (c) any act or neglect of Procuring Entity's employees or
- (d) delay authorized by the Contract Manager pending arbitration or
- (e) the contractor not having received in due time necessary instructions from the Procuring Entit y for which he shall have especially applied in writing to the Contract Manager or his authorized representative.
- (f) hand over possession of the site or the necessary facilities/ documents/ data or instructions by the Procuring Entity to the contractor or
- (g) give the necessary notice to commence the services, or
- (h) any other delay caused by the Procuring Entity due to any other cause whatsoever.
- (i) the contractor may also indicate the period for which the Services is likely to be delayed and a sk for a necessary extension of time. On receipt of such request from the contractor, the Con tract Manager shall consider the same and grant such extension of time as in his opinion is r easonable regarding the nature and period of delay and the type and quantum of work affect ed thereby. No other compensation shall be payable for works so carried forward to the exte nded period. The same rates, terms, and conditions as the original Contract shall apply durin g the extended period.

20.3. Extension of Time for Delay Due to Contractor

If the contractor fails to deliver the Services within the fixed/ extended period for reasons other th an those stipulated in contract, the Procuring Entity may, if satisfied that the service delivery can still be completed within a reasonable time, extend the period further.

On such extension, the Procuring Entity shall be entitled without prejudice to any other right and remedy available on that behalf to recover from the contractor as agreed damages and not by way of penalty Liquidated Damages as per contract clauses.

Provided further, that if the Procuring Entity is not satisfied that the service can be completed by the contractor or in the event of failure on the part of the contractor to complete the service within the extension of time allowed further as aforesaid, the Procuring Entity shall be entitled without prejudice to any other right or remedy available in that behalf, treat the delay as a breach of contract and avail any or all the remedies thereunder, whether or not actual damage is caused by such default.

Inordinate Delays: Delays due to the contractor of more than one-fourth (25%) of the total comple tion period shall be treated as inordinate delays. Such inordinate delays shall be noted as poor p erformance and be held against the contractor in future tenders. A show-cause notice shall be iss ued to the contractor before declaring it a poor performance. Such delays may be considered as a breach of the contract at the option of the Procuring Entity.

21. Suspension of Services

21.1. Suspension Ordered by Contract Manager

The contractor shall, on the order of the Contract Manager, suspend the progress of the Services or any part thereof for such time or times and in such manner as the Contract Manager may consi der necessary, and shall during such suspension, adequately protect and secure the site and asse ts so far as is necessary in the opinion of the Contract Manager. If such suspension is -Provided fo r in the contract, orNecessary for the proper execution of the Services or because of extraneous c onditions or by some default on the part of the contractor and orNecessary for the safety of the S ervices or any part thereof

21.2. Extension of Time and Compensation

The contractor shall not be entitled to the extra costs, if any, incurred by him during the period of suspension of the service, but in the event of any suspension ordered by the Contract Manager for reasons other than aforementioned and when each such period of suspension exceeds 14 days, the Contract Manager shall extend the time of service for completion of the Services as he may consider proper, having regard to the period or periods of such suspensions and such compensations as the Contract Manager may consider reasonable in respect of expenses incurred by the contractor during the periods of such suspension.

21.3. Suspension Lasting More Than 3 Months

If the Contract Manager suspends the Services or any part thereof for more than three months at a time, the contractor may serve a written notice on the Contract Manager requesting permission to proceed with the suspended part(s) of service. If such permission is not granted within 15 days from the receipt thereof, the contractor by further written notice may, treat the suspended part(s) of the service as deleted from the Contract. If the whole of the services has been suspended, he may treat it as a breach of the contract by the Procuring Entity and avail any or all remedies provided in this regard in the contract.

21.4. Force Majeure

- (a) On the occurrence of any unforeseen event, beyond the control of either Party, directly interfe ring with the delivery of Services arising during the currency of the contract, such as war, hosti lities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the affected Party shall, within a wee k from the commencement thereof, notify the same in writing to the other Party with reasonab le evidence thereof. Unless otherwise directed by the Procuring Entity in writing, the contractor shall continue to perform its obligations under the contract as far as reasonably practicable and shall seek all reasonable alternative means for performance not prevented by the Force M ajeure event. If the force majeure condition(s) mentioned above be in force for 90 days or mor e at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this Contract before such termination.
- (b) Notwithstanding the remedial provisions contained in **Damages and Deductions Thereof a nd Termination due to Breach, Default, and Insolvency,** none of the Party shall seek any
 such remedies or damages for the delay and/ or failure of the other Party in fulfilling its obligat
 ions under the contract if it is the result of an event of Force Majeure.
- **22. Permits, Approvals and Licenses:** Whenever the delivery of Services and incidental Goods/ Works r equires the contractor to obtain permits, approvals, and licenses from local public authorities, it shall be the contractor's sole responsibility to obtain these and keep these current and valid. Such requirements may include but not be restricted to licences or environmental clearance if required. If requested by the contractor, the Procuring Entity shall make its best effort to assist the contractor in complying with such requirements in a timely and expeditious manner, without any dilution of the Contractor's responsibility in this regard.

23. Labour Codes and Related Obligations

23.1. Independent Contractor

The contractor's status shall be that of an independent contractor and Primary Employer of staff deployed during the contract by him or his sub-contractors or other associates. The contractor, it s employees, agents, and subcontractors performing under this Contract are not employees or agents of the Procuring Organisation or Procuring Entity or Central or State Government or their agencies/ Enterprises, simply by Services delivered under this Contract.

23.2. Obligations of the contractor under Labour Codes and Rules

- a) In cases where Services are to be performed by the contractor at the premises of the Procurin g Entity or Beneficiary of Services, the contractor shall comply with the provisions of the Labou r Codes including Code on Wages, 2019, The Industrial Relations Code 2020, Code on the Soci al Security 2020, and The Occupational Safety, Health and Working Conditions 2020, and Draft Rules made thereunder, as modified from time-to-time, wherever applicable and shall also ind emnify the Procuring Entity from and against any claims under the aforesaid Labour codes and the Rules.
- b) The contractor shall obtain a valid licence under the aforesaid Labour codes and the Rules as modified from time to time before the commencement of the contract and continue to have a valid licence until the completion of the contract. Any failure to fulfil this requirement, the Proc uring Entity shall treat it as a breach of contract for default as per the contract and avail any o

r all remedies thereunder.

- c) In respect of all labour directly or indirectly employed in the contract for the performance of th e contractor's part of the contract, the contractor shall comply with or cause to comply with th e provisions of the aforesaid Labour codes and the Rules wherever applicable. The contractor shall be solely responsible for submitting all the necessary returns under these Codes and the Rules. Nevertheless, the contractor shall submit monthly returns to the Procuring Entity to con firm compliance with such Codes and rules. Failure to do so shall entitle Procuring Entity to ta ke any measure to ensure compliance to such codes and rules by the contractor and his assoc iates, including, but not limited to, withholding contractor's on-account bills.
- d) The contractor shall pay the wages as per the Code on Wages to their workers not below the r ate of minimum wages, as notified by the State Government or Central Government, whichev er is higher, through the bank transfer. The contractor shall, notwithstanding the contract's pr ovisions to the contrary, cause to be paid the wages to labour directly or indirectly engaged on the contract, including any engaged by his Sub-Contractors in connection with the said contract as if he had immediately employed the labour. The Procuring Entity shall, without any commitments or being obliged to do, may its discretion, monitor that such payments are being made. The contractor shall be required to submit, every month, documentary evidence in the form of a Bank Statement of having transferred the gross minimum wages to each worker. Failure to do so shall entail Procuring Entity taking up any measure to ensure the payment of wages including, but not limited to, withholding contractor's on-account bills.
- e) In every case in which, by virtue of the provisions of the aforesaid Labour codes and the Rules. the Procuring Entity is obliged to pay any amount of wages to a workman employed by the co ntractor or his Sub-Contractor in execution of the contract or to incur any expenditure in provi ding welfare and health amenities required to be provided under the aforesaid Labour codes a nd the Rules or to incur any expenditure on account of the contingent liability of the Procuring Entity due to the contractor's failure to fulfil his statutory obligations under the aforesaid Labo ur codes and the Rules the Procuring Entity shall recover from the contractor, the amount of w ages so paid or the amount of expenditure so incurred, and without prejudice to the rights of t he Procuring Entity under the aforesaid Labour codes and the Rules, the Procuring Entity shall be at liberty to recover such amount or part thereof by deducting it from the security deposit and/ or from any sum due by the Procuring Entity to the contractor whether under the contrac t or otherwise. The Procuring Entity shall not be bound to contest any claim made against it u nder the aforesaid Labour codes and the Rules except on the contractor's written request, and upon giving the Procuring Entity complete security for all costs, for which the Procuring Entity might become liable in contesting such claim. The decision of the Procuring Entity regarding t he amount recoverable from the contractor as stated above shall be final and binding on the c ontractor.

23.3. Occupational Safety, Health, Working Conditions, Social Security, and Industrial Relations Requirements:

As per Labour Codes, which included Code on Wages, 2019, The Industrial Relations Code 2020, Code on the Social Security 2020, and The Occupational Safety, Health and Working Conditions 2 020 and rules thereunder, the following provisions shall be ensured by the contractor.

23.3.1. Provisions for Workers:

At his own expense, the contractor shall make adequate arrangements for the housing, supply of drinking water, and provision of clean sanitation, including urinals, etc., for his staff and workers, directly or through the petty contractors or sub-contractors.

The contractor shall also provide a temporary creche (Bal-mandir) where 50 or more wo rkers are employed at a time.

Suitable sites on Procuring Entity's land, if available, but without any obligation to do so , may be allotted to the contractor for the erection of labour camps, either free of charg e or on such terms and conditions that the Procuring Entity may prescribe.

All camp sites shall be maintained in clean and sanitary conditions by the contractor at his own cost.

During the execution of services, unless otherwise stipulated in the contract, the contractor shall at his own cost provide the following materials as is necessary for:

- (a) The safety, hygiene, satisfaction, elegance, acceptance, proper handling of assets a nd shall ensure that no damage, injury, or loss is caused or likely to be caused to an y person or assets or hindrance to other works/ services.
- (b) Environmental requirements to conserve energy, water, wood, paper, and other res ources, reduce waste, phase out the use of ozone-depleting substances, and minimis e the release of greenhouse gases, volatile organic compounds, and other substance s damaging health and the environment.
- **23.3.2. Medical Facilities:** the contractor shall provide medical facilities at the site as prescrib ed by the Contract Manager on the advice of the Procuring Entity's Medical Authority commensurate with the strength of the contractor's resident staff and workers. Such facilities shall include a First-Aid facility manned with staff trained in first aid as per labour codes or the Contract Manager's directions.

23.3.3. Medical Certificate of Fitness for Labour

The contractor shall not employ a person below 18 years of age. For delivery of Services under the contract, unless a medical certificate of fitness in the prescribed form under la bour codes (or as directed by the contract manager) is granted to each worker by a cert ifying surgeon certifying that he is fit to work as an adult, is obtained and kept in the cu stody of the contractor or a person nominated by him in this behalf and the person carri es with his, while at work, a token giving a reference to such certificate.

- (i) Period of Validity of Medical Fitness Certificate: A certificate of fitness granted or ren ewed for the above-said purposes shall be valid only for one year at a time. The ce rtifying surgeon shall revoke a certificate granted or renewed if, in his opinion, the holder of it is no longer fit for work in the capacity stated therein. Where a certifyin g surgeon refuses to grant or renew a certificate or revoke a certificate, he shall, if so required by the person concerned, state his reasons in writing for doing so.
- (ii) Medical Re-Examination of Labour: Where any official appointed on this behalf by the Ministry of Labour believes that any person employed in connection with the execution of any work under this Contract in the age group 18 to 65 years is without a certificate of fitness or is having a certificate of fitness but no longer fit to work in the capacity stated in the certificate, he may serve on the contractor, or the person nominated by him in this regard, a notice requiring that a certifying surgeon and such person shall examine such persons shall not if the concerned official so directs, be employed or permitted to do any work under this Contract unless he has been medically examined and certified that he has been granted a certificate of fitness or a fresh certificate of fitness, as the case may be.

24. Governing Laws and Jurisdiction

24.1. Governing Laws and Jurisdiction

This Contract, its meaning and interpretation, and the relation between the Parties shall be gover ned by the Laws of India for the time being in force.

Irrespective of the place of delivery, or the place of performance or the place of payments under the contract, the contract shall be deemed to have been made at the place from which the Letter of Award (LoA, or the contract Agreement, in the absence of LoA) has been issued. The courts of such a place shall alone have jurisdiction to decide any dispute arising out or in respect of the contract.

24.2. Changes in Laws and Regulations

Unless otherwise stipulated in the contract, if after the last deadline for the bid submission (Techn o-commercial), any law, regulation, ordinance, order or bye-law having the force of law is enacted , promulgated, abrogated, or changed in India (which shall be deemed to include any change in i nterpretation or application by the competent authorities) that subsequently affects the Delivery Date and/ or the contract Price, then such Delivery Date and/ or Contract Price shall be correspondingly increased or decreased, to the extent that the contractor has thereby been affected in the performance of any of its obligations under the contract. Notwithstanding the foregoing, such add itional or reduced cost shall not be separately paid or credited if the same has already been acco

unted for in the price adjustment provisions where applicable.

25. **NOTE**: - In addition to above conditions, the other terms & conditions shall be applicable as per enclos ed General conditions of contract & scope of work&other terms and condition of contract under this ten der document.

26. Price Escalation and Tax & Duties: -

The escalation will be paid up to the scheduled completion date including duly ap proved Time extension, if any. No escalation will be attracted for the period beyond duly approved time extension.

Adjustment for revision of minimum wages during the order executio
