4. ### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

### 2. Buyer Added Bid Specific ATC

#### I. PRE-QUALIFICATION CRITERIA:

The Tenderer who wish to participate in the Tender needs to fulfil the following Qualifying Criteria.

1. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which tenders should be either of the following
  - a. Three similar completed works each costing not less than the amount equal to Rs.698872/-  
(or)
  - b. Two similar completed works each costing not less than the amount equal to Rs.873589/-

The bidder should submit his PAN card, GST registration, PF registration, IT returns of the last three financial years ending 31.03.2024, Audited Balance sheet and Profit and Loss statement of the last three financial years ending 31.03.2024 should clearly indicate the details of the Membership No.& Firm No. of the Chartered Accountant& UDIN, if required, as per guideline of ICAI. If one year is fulfilling the minimum average financial turnover, party gets qualified for turnover criteria.



Documentary evidence of all the above to be submitted as proof.

## **SCOPE OF WORK**

1. Checking auxiliary supply and control voltage of the relay.
2. Checking the connections of the relay as per the circuit diagram and if any corrections needs to be attended. Cleaning of relay contacts with aerosols for foreign material removal. Relay checking must consists of inspection and polishing of contacts, foreign matter removal, screws checked for tightness and secondary injection test.
3. Details of fault as per the LED indications should be written on relay and spare LED shall be written as SPARE. All the data that is available in the relays has to be taken from relay by connecting to PC/laptop through relevant software and must give us a copy of data feeder/relay wise in a pen drive/CD. At present we are not having the fault calculations/ relay setting calculations data which was stored in the relays, so before starting the work, the backup data of the relays must be kept in the laptop/PC and again the same data has to be used through laptop during testing/functional verification of relays.
4. Relay Testing as per existing protection settings. Functional verification of relays along with the parameter checking has to done by the contractor. Providing suggestions if any wrong settings found and correct it.
5. CT and PT secondary wire tightness checking.
6. All the test kits and other accessories which are required for testing of relays are in the scope of the contractor.
7. Test reports has to be issued from authorised testing agency approved by AP state government. NABL Calibration certificates has to submitted to UCIL for the test kits which are used for testing of relays. Detailed procedure has to be given in writing for the tests which are being conducted on relays.
8. For Auxiliary relays/Electromechanical relays, checking AC/DC supply. Cleaning of relay case and relay contacts. Relay checking must consists of inspection and polishing of contacts, foreign matter removal, screws checked for tightness and secondary injection test. Insulation test between relay case and each terminal, Insulation test between relay case and AC/DC circuits, insulation test between AC/DC circuits and terminals normally separated by open contacts.
9. Following tests shall be carried out
  - a) Testing of relays with test kit
  - b) Functional verification of individual feeder
  - c) Simulation test for tripping of related feeder

### **SECURITY DEPOSIT**

The Amount of Security Deposit including the amount of Earnest Money shall be 10% of the awarded value of work. Fifty percent of this amount shall have to be deposited as initial security deposit at the time of execution of agreement including the amount deposited as Earnest Money.

In addition to the above, balance fifty percent of Security deposit shall be deducted from running bills. If the full amount of security deposit is realised / retained by the corporation.

Failure in carry out the awarded work shall entail forfeiture of the security deposit. Security deposit will be refunded without any interest on written request in duplicate to the Engineer-In-Charge after six months of satisfactory completion of the work order. This will be released after successful completion of the work and taking over & on submission of PBG till defect liability period.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
