2. The Pre-qualification criteria (PQC) to qualify in Techno commercial Part are as below:-

1. The Bidder must have experience in similar nature of works in last seven years to any central/ State Govt. Organization / PSU / Public Listed Company ending last day of month previous to the one in which applications are invited should be either of the following:-
 - a) One similar nature of work not less than 80 % of the estimated value of the work
Or
 - b) Two similar nature of work not less than 50 % of the estimated value of the work
Or
 - c) Three similar nature of work not less than 40 % of the estimated value of the work.
2. Minimum average turnover 30 % of the estimated value of the work for last 3(three) financial years and submission of duly audited copy of Profit & loss account and balance sheet of financial years 2021-22, 2022-23 & 2023-24 by Chartered Accountant.
3. Similar Works means-“**Any Work at Underground Metal Mines**”.
4. The parties have to give a declaration that they have not quoted rates of wages below the minimum wage prevailing on 01-10-2024 plus the statutory payment towards EPF, PF, Administration charges, E DLI, Bonus etc.

5. The Bidder shall furnish a copy of MSME/NSIC, ESIC, PAN, GST and PF Registration Number, ITR of the last three financial years.

6. GEOGRAPHIC PRESENCE:

Office registration certificate: Registered office or at least one of the registered branch office of the bidder shall be located and registered within the geographical limits of Dist - **East Singhbhum, Jharkhand** state where the services needs to be provided. Documentary evidence must be provided in the form of Municipality trade licence or other such documents as per the following which satisfies as a proof of having the office establishment.

A) Trade licence issue by the local authority in the name of the Firm or

B) Landline phone number in the name of the Firm or

C) Electricity bill for last one year in the name of the Firm or

D) GSTIN registration or

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.

10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
