6) SCOPE OF WORK-

- The scope of this Bid will be generally as per specification, working drawings, schedule of quantities and general / s pecial conditions of contract and as directed by Engineer in charge, on behalf of Corporation. However minor construction work covered complete in all respect including finishing under this contract are as follows:
- (a) Supply of 03 nos. of Semiskilled manpower for pump operation (Daily basis including Rest day and Holiday) at Ja hersthan area at Jaduguda tailing Dam. (01 reliever on rotation basis)
- (b) Supply of 03 nos Unskilled manpower for miscellaneous work at Jaduguda tailing pond dam.
- (c) Maintenance of tailing pipe line including dismantling, laying and shifting the pipe line.

- (d) Removing cattle from tailings pond area for smooth operation
- (e) Transporting, fixing, the sleeper in spillway channel at both ends.
- (f) Cleaning, washing the jammed pipes and drain cleaning, Grass cutting and Road preparation and various type of job related to tailing Dam.
- (g) All tools and tackles to be arranged by the Contractor at own cost. Cleaning, wire brushing, removing rust or dus t, spillage or any other chemical over pipeline.
- (h) Pump operation should be round of clock (all 03 shifts A, B, C), and Unskilled labour to be supplied normally in G-shift and in case of emergency whenever required (in any Shift) as per work requirement.
- (i) Medical and Height pass from UCIL Safety department of all workers engaged in painting work is a must requirem ent and without this work cannot be started.
- (j) All temporary work for execution of the work like construction of go down, temporary road etc, No separate paym ent will be paid for this work.
- (k) Any equipment, material or services other than reimbursable safety appliances which are not mentioned in the B id document but required for completion of the work in safe and efficient manner shall be deemed to be include d.

All work for civil item shall be carried out as per latest relevant Indian standards, CPWD/ISI and MOST specification wh ich shall form part of this specification and instruction of the Engineer in Charge in case of conflict or where an a spect of work is not covered by the Indian Standard and specification Engineers instruction shall be strictly followed.
