Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price

within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

The eligible criteria to qualify in Techno commercial Part are as below:

- Average Annual financial turnover during the last 3(Three) consecutive financial years, ending **31.03.2024** shall be at least 30 % (**Rs. 49,115.40 Thousands**) of the estimated cost supported by the audited annual accounts of each year.
- Bidder shall have successfully executed similar work during last 7(seven) years ending on last date of bid closing date as per any one of following:
 - Three (3) similar completed work each costing not less than the amount equal to 40 % (**Rs. 65487.20 Thousands**) of the estimated cost or

3. Bidders must attach Work done certificate mentioned executed amount and date of completion and completion certificate.

5. **Vehicle Make,Model,& Conditions of the Tractors with trolley(Hydraulic system):** The tractors with trolley (hydraulic system) offered should be under the administrative control of the tenderer.**The manufactured of tractors should not be earlier than January 2021.**It should be in excellent conditions complete with good seats,tyres & stepney etc.UCIL has the right to inspect the tractors in details before any further processing and if the quality is not good, the tender will be rejected without assigning any reasons whatsoever.UCIL will have the sole right to decide the quality of the tractors.**The tractors with trolley (Hydraulic system) must have commercial registration. The capacity of the tractors with trolley should be minimum 100 cubic feet.**
6. All related documents should be attached/ uploaded by Bidder should be clear and visible otherwise bid will be rejected.
7. Party should be MII class 1 local supplier. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate regarding the percentage of the local content along with their bid, failing which the bid is liable to be rejected

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
