### **Tailings Pond-**

Tailings is generated as a result of ore processing which is pumped to engineered tailings pond located adjacent to plant site. The tailings dam is constructed at location preferably having natural barriers (hills) from three sides with one side earthen dam or rockfill fill. Filter are provided in the dam with toe drain system. The dam is designed as per guidelines regulatory authority, AERB and is duly approved. As per AERB guidelines, tailings pond should be lined with material with coefficient of permeability in the order of  $1.018 \times 10^{-9}$  m/sec with necessary quality control tests to reduce seepage and contamination of ground water. Garland drains is provided to divert the rainwater of the catchment area away from the tailing dam. While designing the garland drain, rainfall for 1000 years of return period is considered. The waste water along with precipitation from tailings pond is decanted through spillway channels. The decant water is ETP for its reuse & recycle. Monitoring bore wells are constructed around the tailings pond for regular monitoring of ground water. Piezometer, settlement gauge and inclinometer are installed on tailings dam for regular monitoring at various sections and levels.

Jaduguda Ore Processing Plant has three numbers of tailings ponds. Tailings pond (Stage-2) have been filled up to the designed capacity which was constructed between two parallel with only one embankment. First phase of rehabilitation of tailings pond has been completed by putting a compacted clay layer of 300 mm.
