- 3. They are also advised to physically visit the site if required to understand site worki ng conditions, nature & mode of operation of jobs prior to quote for the same.
- 4. The Tenderer shall submit his tender strictly in accordance with the tender specificat ion and terms & conditions laid down in the tender document. Physical submission of tender (offline submission) by Post / Courier will not be accepted.
- 5. - 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.
