OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

PRE-QUALIFICATION CRITERIA (PQC)/ ELIGIBILITY CRITERIA

1. PAST PERFORMANCE AND PROJECT / PAST EXPERIENCE etc. CRITERIA:

Bidder shall have successfully completed similar works during current or last 7 (Seven) years ending on bid opening date as per any one of following:

1. Experience of having successfully completed similar works during current or last 7 (Seven) years ending last day of month previous to the one in which applications are invited should be either of the following:

Three similar completed works costing not less than the amount equal to 40% of the estimated cost (60,02,362/-)

2. FINANCIAL STANDING:

SCOPE OF WORK:

1. Repair and Maintenance of Load Haul Dumpers, Low Profile Dump Trucks, Drill Jumbos and Services Vehicle at Bagjata Mine both surface and underground in all three shift excluding national /paid holidays enlisted in UCIL calendar. It includes the following: -
 - Daily maintenance {Schedule, Preventive and Breakdown}
 - Repairing of major components like Engine, Transmission, Converter, Axle, Drifter etc
 - Small sub-assembly repair including Engine top overhauling, Chassis Frame Repairing etc.
 - Schedule & Preventive maintenance (As per OEM Maintenance schedule)
 - Tyre Repairing and fitment and preparation of spare wheel.
 - Troubleshooting diagnosis
 - Provision of manpower for maintenance and storage of material etc
 - Any other activity/work necessary to maintain the machine on working condition etc
 - Providing required set of machine/Equipment in each shift.

2. Scope of Bidder:

- 1) The contractor shall provide minimum Three numbers (03) underground Highly skilled, Nineteen numbers (19) underground Skilled, Thirteen numbers (13)

underground Semi-skilled, and Three (03) underground unskilled persons to execute the jobs. Insurance, Weekly rest and leave will be applicable as per respective act.

2) The Bidder shall provide the following on reimbursable basis by UCIL subject to submission of proper documentary evidence/bills/invoice/ valid gate pass data duly signed by security, etc along with RA bills. The amount shall be reimbursed by UCIL up to the ceiling value mentioned in the ATC and as below.

- a) 3 National Paid Holidays for all 38 workmen.
- b) Insurance of all employees for the entire tender duration as per respective act for underground mines premises.
- c) Leave with wages provision as per Admin Ins. No: UCIL/DGM(P & IRs)/GEN/2024, Date: 07/09/2024 under Mine Act 1952 and factory Act 1948. and the amount will be reimbursed on actual payment calculated on the basis of prevailing rates.
- d) Ensure safety appliances and PPE for all engaged manpower for the entire tender duration by providing Safety PPE.
- e) Tools and tackles to be provided to all workmen.
