2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

SCOPE OF WORK

The scope of work includes operating Underground Diesel Vehicles like LHD/ST/LPDT/MT and dumping in underground ore pass Grizzly / at the surface as per instruction of Engineer in Charge. Operator also requires operating vehicles of scissor lift, crane truck, passenger carrier etc in each of three (A, B, C) shifts in a day for 610 Days.

The contractor shall maintain minimum 17 (Seventeen) skilled persons in a day for all working days in a week for 610 Days.

EXPERIENCE OF OPERATORS TO BE DEPLOYED

At latest two year experience as authorized in operation of underground diesel operated equipments or have worked as authorized drivers of other vehicles running in a mine or operation of heavy vehicles

Bidder shall prefer operators having experience in operation of underground diesel operated equipments.

QUALIFICATION OF OPERATOR REQUIRED:

The Operators proposed to be deployed should be Heavy vehicle license holder and Literate and have Authorization to work in a mine in last 2 years as on ending last day of month previous to the one in which tender is invited.

- b) Two (2) similar completed works each costing not less than the amount equal to 50% (71.90 Lakhs) or

Bidders must attach Work done certificate mentioned executed amount and date of completion also attached Work order with bill of quantities for related job completion certificate

The bidder shall visit the proposed work site to well acquaint about the site work before filling the rate /submit the tender.

2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be at least 43.14 Lakhs. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant /Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
