However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Buyer Added Bid Specific ATC

### PRE-QUALIFICATION CRITERIA (PQC)/ ELIGIBILITY CRITERIA

The followings are the Eligibility criteria for this Non-divisible service Contract. The bidder may visit the proposed work site to get well acquainted about the site work before filling the rate/submit the tender.

#### 1. PAST PERFORMANCE AND PROJECT / PAST EXPERIENCE etc. CRITERIA:

Bidder shall have successfully completed similar works during last 7 (Seven) years ending on bid opening date as per any one of following:

1. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

Three similar completed works costing not less than the amount equal to 40% of the estimated cost **(15.33 Lakh)**

OR

Two similar completed works costing not less than the amount equal to 50% of the estimated cost **(19.17 Lakh)**

OR

One similar completed work costing not less than the amount equal to 80% of the estimated cost **(30.67 Lakh)**

The "Similar Work" means "**Experience in execution of work with any Central/ State Govt. Organization / PSU/ Public Listed Company for any civil work or manpower supply.**"

#### 2. **FINANCIAL STANDING:**

Average annual financial turnover during the last three financial years should be at least 30 % of the yearly estimated Cost **(11.50 Lakh).**

#### 3. **GEOGRAPHIC PRESENCE:**

Office registration certificate: Registered Office within the geographical limits of **East Singhbhum District of Jharkhand state** where the services need to be provided. Document any evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.



- I. Trade License issued by the local authority in the name of the Firm or
- II. Local Employee Exchange registration for contractor as per Govt. of Jharkhand. or
- III. GSTIN registration or
- IV. Udyam Certificate.

Without submission of the above documents for Office address in the State of Jharkhand, then the tenderer will be disqualified in Techno Commercial bid.

4. EPF registration copy, ESIC, GSTIN copy & Make in India Compliance must be submitted along with the bid.
5. Any bid not complying PQC requirements shall be summarily rejected.
6. EMD exemption only to relevant MSME/MSE.
7. Prior Turnover and prior experience exemption for relevant Startups and all MSE's as per government guidelines.
8. The tender documents shall be issued free of cost to company/units registered with MSME/National Small Industries Corporation/Director of Industries of State, Cottage Industries approved by the State Authority or any other entity as may be specified by Govt. guidelines from time to time, after ensuring that the approval pertains to the class of item/works for which tender is floated.

#### NOTE:

If the works are provided by the contractor in accordance with this contract, Corporation will pay to the contractor the price (awarded value); and reimburse the contractor for the approved expenses (as specified in the order/ contract), after the approved expenses have been incurred by the contractor. Corporation will not be liable to reimburse the contractor for expenses other than approved expenses, unless Corporation's prior approved written consent.

The UCIL shall pay on reimbursement basis to the total applicable GST @ prevailing rate as per GST rule on total transaction value (i.e. price actually paid to the service provider) after deduction of GST amount from the amount mentioned in the contract rate. GST on penalty, interest, non-related expenses and applicable GST on forfeiture of SD/ retention money/ EMD etc. shall not payable.

#### **Scope of work:**

1. All the required labour, tools and tackles required for work etc. are in the contractor's scope.
2. PPE's i.e. Safety Shoe, Gumboot, Uniform, Safety Jacket, Nose mask, Ear plug, Safety goggles, Safety belt, Safety helmet to be provided by the contractor.
3. No extra required labour, tools and tackles and safety items etc. are not be provided by UCIL.
4. The removal from the site of any material brought there on by the Contractor and the substitution of any other material thereof. No extra payment will be made for this.
5. Schedule of items mentioned in Bill of Quantity or as per directions of Engineer-in-charge.
6. The scope of work also includes the following for which no extra payment will be made. Therefore, contractor may consider this while quoting their rate of other items as mentioned under bill of quantities for various items of work.
7. Inform UCIL person for the disposal in a safe and lawful manner of all effluent, waste products a

nd used items resulting from the construction and maintenance of the work.

8. Insurance for all personnel under workman compensation Act.

Note: - Contractors are advised to see the area get acquainted with the actual features of the land where work is to be executed and get other related information before quoting their rates for carrying out the work successfully.

2c. **Scope of Bidder:**

- 1) The contractor shall provide minimum One numbers (01) above ground Semi- skilled, Seven numbers (07) above ground unskilled persons to execute the jobs. Weekly rest and leave will be applicable as per respective act.
- 2) The Bidder shall provide the following on reimbursable basis subject to submission of proper documentary evidence/bills/invoice etc along with RA bills. The amount shall be reimbursed up to the ceiling value mentioned in the ATC and as below.
  - a) 3 national Holidays for all 07 workmen.
  - b) Insurance of all employees for the entire tender duration as per respective act for mines premises.
