Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

2. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

The eligible criteria to qualify in Techno commercial Part are as below:-

1. Average Annual financial turnover during the last 03 (Three) consecutive financial years, ending 31st March of the previous financial year, should be at least 30% (4.09 Lakhs) of the estimated cost supported by the audited annual accounts of each year.

2. Bidder shall have successfully completed similar works during last 07 (Seven) years ending last day of month previous to the one in which application are invited should be either of the following:-

a) Three (03) similar completed works each costing not less than the amount equal to 40% (5.45 Lakhs) of the estimated cost

or

b) Two (02) similar completed works each costing not less than the amount equal to 50% (6.81 Lakhs) of the estimated cost

or

c) One (1) similar completed works costing not less than the amount equal to 80% (10.90 Lakhs) of the estimated cost.

3. Bidders must attach Work Order and work done certificate mentioned executed amount and date of completion.

4. Similar works means, Experience in execution of work of any "Drilling of Bore Hole".

Scope of work

Scope of Work:-

1. Total core drilling of 1250 meter approximately with borehole depth varying from 100 to 300 meter with 100 mm (HQ) diameter.

2. A minimum of 01 (one) Surface Non-Core drilling rig capable to drill up to 300 meter or more than in 'HQ' size should be deployed in the area.

3. The minimum rate of progress of 350 m per month should be ensured.

4. Boreholes drilled should conform to the following standards:

a) 100mm (HQ) diameter

b) Inclined (50° to 85°) and Vertical Bore Holes (Angle will be checked by the Geologist before commencement of the borehole)

c) Deviation in borehole Angle of maximum 20 for each 100 meters of depth will be allowed in each borehole. Therefore, the contractors are advised to take all precautions to drill the boreholes within these limits. The aforesaid diameter shall be considered as finished diameter. In case where

d) Considerable collapse is noticed and it is difficult to keep the borehole clear for the purpose of the gamma ray logging, boreholes have to be cased by the insertion of 125 mm. PVC casing upto the end depth of the boreholes or upto that depth where remains minimum chances of sagging within the boreholes.

Drilling shall normally conform to the above standards. However, considering the lithology, structure of the rock and in-hole conditions, the standards on deviation and drift may be assessed as per site conditions and relaxed by the Geologist after ensuring that the bore hole has served the purpose.

5. The geological formations to be drilled are mainly in Feldspathic Schist, Quartz Chlorite Schist, Quartz-Sericite Schist and Quartzite rock formation.

6. No borehole should be closed until gamma ray logging is completed. The gamma ray logging of the boreholes will be done only during the day time. Approval of the Geologist should be taken before closure of the borehole. Every effort will be made by the Geologist to have the logging completed at the earliest.

7. The borehole opening should be covered by a concrete pillar with the borehole number engraved on it before removing the Rig from the borehole point. In case it is not possible to construct the concrete pillar due to the objections from the land owner(s), the borehole mouth should be properly sealed.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
