If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

PRE-QUALIFICATION CRITERIA FOR THE BIDDERS

i) Experience of having successfully completed similar work during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:

a) One similar completed works costing not less than the amount equal to Rs. 5,89,566.00/-

Or

b) Two similar completed works each costing not less than the amount equal to Rs 3,68,479.00/-

Or

c) Three similar completed works each costing not less than the amount equal to Rs 2,94,783.00/-

“Similar work” means experience in mechanical fabrication work like Cutting, Welding, Remetalling, Machining, Line Boring, Drilling, Tapping, Bushing & Alignment etc.

Copies of work orders with either a) completion certificate or b) Performance certificate or c) Contract agreement as documentary evidence should be provided to prove above experience.

ii) The tenderer's minimum average annual turnover during last 03 years, ending 31st March of the previous financial year should be at least Rs.2,21,087/-. Annual Report containing Profit & Loss account and Balance sheet for last 3 financial years must be submitted.

ii) Geographical Presence: Proof of having Registered Office and workshop located and registered within the home state of the buyer i.e. Jharkhand where the services needed to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.

i. Trade License issued by the local authority in the name of the Firm OR

ii. Incorporation Certificate of the firm clearly mentioning office address OR

iii. Electricity bill for last one year in the name of the Firm OR

iv. GSTIN registration

Scope of Work

1. The work has to be done at Contractors Site outside UCIL Premises.

2. Transportation/ Handling of Parts (to and fro) for machining work will be in Contractors Scope and no extra charges will be paid for the same.

3. Dismantling, Cleaning, Rematelling, Machining and Assembly work has to be done as required at contractors site.

4. Rematelling/ Machining of Cylinder Bracket of Jumbo with new Expandable Pin (2 nos.) and front Pin (01 nos) with alignment and fitting work to be done.

5. Rematelling/ Machining of Boom Link of Jumbo with new Expandable Pin (4 nos.) + required Brass Sim with alignment and fitting work to be done, with all bushes and sim as per OEM.

6. Drawing has been attached as Annexure - AB

7. Drilling, Tapping & Recoiling work to be continued as per Drawing attached.

8. No Extra parts will be provided for the said job.

9. Finally Painting work with Golden Yellow colour to be done.

10. Frequent visit will be done by Engineer in-charge or his representative for inspection of the work.

11. Sample is not available, hence party must arrange at their own responsibility and expenses, to take the measurement for sample, from other running machine in between 7 am to 9 am with previous intimation, so as for availability of the machine on surface.

12. All Grease Holes with grease Nipples to be provided as per OEM drawing attached.

13. Work to be completed within 2 phase, After the completion of First assembly, it will be fitted on machine within 15 days, and after that second assembly will be provided for completion of the job.

14. The work has to be completed within 6 months within 2 phase, after which penalty clause will be applied.

If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
