- 1. - 4. The Tenderer should mention their Price/ Item rates in figures as well as in words. In case o f any dispute / ambiguity, the price/ rates mentioned in words shall be considered as final. No insertions, postscripts, additions and alterations shall be recognised unless confirmed by the Tenderer's signature.
- 5. Tender bids (Technical as well as price) shall be submitted strictly in a manner asked givin g full details / information necessary for assessing their offer
- 6. Canvassing in any form is strictly prohibited and any Tenderer found to have resorted to c anvassing or influencing other Tenderer shall be liable to have his tender rejected summarily.
- 7. Tender documents are not transferable.
- 8. Special Note:

- 9. Any failure by the vendor/contractor to execute the contract as per tender term s and conditions may result in black listing of respective vendor's /contractor for a period of 01 year for a period of minimum 01 year to maximum of 02 years.

The scope of the work is mentioned below in detailed. All the jobs related this tender has to be done at the contractor's work place. All the jobs regarding this tender are been given on need basis depending on availability at site and contractor has to agree for the same. These jobs shall have to be done by the Contractor with required resources like manpower, machines, tools & tackles, supervision etc. within mutually agreed time period at their ex-works only.

The Scope of work in each activity is briefly mentioned below.

Scope of work of Bidder:

- 1. Transportation of damaged cylindrical rollers from UCIL, Tummalapalle Site to Party Ex-Works and transportation of repaired rollers from the Ex-Works to UCIL, Tummalapalle site is completely in the scope of Supplier only.

- 3. Repairing of rollers may be
- i) Removal of bend, ii)Replacement of both the end covers and stub shafts, ensuring straightness or roller a nd cylindrical shape, if require cylindrical grinding is to be done.
 - iii) Straightening of rollers, iv) Welding of End bearing portions, iii) welding of any holes formation on the cylindrical surfaces and re-machine of the surface etc..
 - 4. The spot areas where the shaft has been heated and aligned using the welding torch must be clea ning using chemical pickling and or mechanical abrasive polishing.
 - 5. All consumables are in the scope of Bidder only.
 - 6. Removing of all burs on the surface of the Roller.

Warranty/ Guaranty: 06 months from the date of dispatch on faulty materials used & the bad/Poor w orkmanship on the cylindrical rollers.

Inspection: (if necessary).M/s UCIL representatives will inspect the material at the bidder's ex works a fter completion of Job and prior intimation from the bidder. All the charges will be borne by the UCIL fo r inspection at the bidder's works.

UCIL scope:

- 1. Will provide the necessary gate pass, E-way bill etc..
- 2. Loading & Unloading of materials.

E. E.M.D.:

Offer shall be accompanied by EMD for an amount of **Rs. 10,000.00 (Rupees Ten Thous and Only)**. EMD shall be by way of a Demand Draft drawn in favour of "Uranium Corporati on of India Limited" payable at SBI Pulivendula Branch (**Code No. 0989**). No cash or chequ e in any form will be accepted as earnest money. No interest will be paid on the earnest money deposit. Tenders received without earnest money deposit will be summarily rejected.

Return of earnest money: The earnest money of successful Tenderer will be adjusted into a curity deposit after signing of contract agreement. The earnest money of unsuccessful Tenderer

In addition to the above, further amount to the extent of the **2.5%** of awarded value of the wc will be deducted from the running account bills by way of percentage deductions. F. PENALTY / AGREED LIQUIDATED DAMAGE:

Time shall be the essence of the contract. Bidder shall have to send the repaired rollers within 4 months from the date of lifting the material from TMPL Site. If successful Tenderer fails to e cute the order within the agreed stipulated schedule, he shall be liable to pay agreed liquidate damages a sum @ $\frac{1}{2}$ % of the order value per week or part thereof of delay subject to a maximum of 5%. In case of delay beyond 10 weeks, UCIL reserves the right to cancel the order and et the balance work/procurement done through any other agency at your risk and cost.

G. DEFECT LIABILITY PERIOD:

Defect liability period for repaired rollers shall be six months from the date of receipt of mater I at UCIL Site. In case of defects if any, the defects shall be rectified at free of cost on "free at ur site" basis within one month of information of the defect. In case of delay in attending the fect as stipulated above, the defect liability period shall get automatically extended.

H. PAYMENT TERMS:

- · Bill (s) will be paid as through Running "**RA bills"** as mentioned in clause "Bills" of the Scope of Work of contract document.
- Payment will be released after satisfactory completion of the work in all respect an d certification by the Engineer-in-charge, UCIL within 30 days of submission of clear bill in triplicate along with tenderer's letter head. Contractor shall mention actual d ate of commencement of the work in their bill (s). Final bill will be released only after submission of Annual Return (Format to be obtained from Site Office Mill) and work completion letter in duplicate by the contractor.

I. VALIDITY OF OFFER:

The offer should remain valid for a minimum period of Six months/180 Days from th e date of opening of the tender. The Tenderers shall not be allowed to increase, amend or withdraw his tender within this period and if he does so, he will be liable to take action as mentioned in Bid security declaration form.

J. PERIOD OF CONTRACT:

The contract period shall remain valid for a span of 04 months from the date of actual co mmencement of work after successful site mobilization. Site mobilization shall have to be done wit hin 15 days on receipt of LOI indicating contract price of the work. However, date of actual start of work shall be fixed by UCIL.

K. EXTENSION OF CONTRACT:

As the proposed works are not continuous job throughout the tenure and purely depends on the availability & provision of Site from UCIL, in case of emergency demanded from the plant, after taking proper justification from the indenter, the Contract may be extended (on repeat order basis) for further 01 months after successful completion of initial contract period with same rate, terms & conditions of the contract with mutual consent, if so deemed fit by UCIL and agreed by the bidder.

The tenure/period may be extended (if the contract value is not consumed due to u nforeseen reasons) further up to 02 months after successful completion of initial contract p eriod with same rate, terms & conditions of the contract with mutual consent, if so deemed fit by UCIL and agreed by the contractor.

L. VARIATION IN QUANTITY OF ITEMS:

Variation in quantity of items mentioned under scope of work: The quantities mentione against individual items are tentative. The actual quantities of individual items may vary (f m those indicated in the tender documents due to actual conditions of the site or due to othe easons) to any extent, keeping the actual value of total work done well within $\pm 10\%$ on the ontract sum or work order value. The contractor shall carry out all work up to total variations f $\pm 10\%$ on the contract sum or work order value and all tendered rates shall remain firm with this limit. Any individual item may vary to any extent and be excluded altogether.

M. Subletting of contract:

Subletting of the contract in any form is not allowed.
