- 3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 5. If L-1 is not an MSE and MSE Service Provider (s) has/have guoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE
- bidder subject to acceptance of L1 bid price.

- 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost: or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

The bidder will have to submit copy of the r elevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate from the client as documentary evidence in support of their experience / credential failing which offer sh all be summarily rejected. All submitted experience and past performance documents such as Work Ord er, Completion certificates etc. shall be either English and/or Hindi Language only. Credentials other than English or Hindi language shall not be considered and their offer may be out rightly rejected. Bidders have to upload documentary proof of PAN, GST registration no. and EPF A/C. No. and ITR/Annual report containing balance sheet and statement of profit & loss audited by registered Chartered Accountant and duly signed unconditional acceptance letter (Covering letter) of UCIL's tender conditions or A uthorized letter / Undertaking letter.

The tenders are to be uploaded at GeM portal before due date fixed for receiving the bid. Physical submission of tender shall not be accepted. Earnest Money deposit (EMD) is to be remitted by the way of demand draft only in favor of Uranium Corporation of India Limited. MSEs seeking exemption and ben efits should enclose a copy of valid registration certificate, giving details such as validity, stores/services etc. and submit before opening date and time of techno-commercial bid as mentioned a bove failing which they run the risk of their bid being passed over as ineligible for the benefits applicable to MSMEs. No cash, MO, fund transfer etc is to be accepted.

Tenderer shall upload a scanned copy of EMD and enclose the original EMD (If the bidder claims exemption from EMD, Hard copy of MSME, NSIC, etc. relevant certificate) in an envelope mentioning NI T No. and name of the work in the super scribed and send (postal /physical) it to the Office of DG M (I/P & IRs.), UCIL, Jadugoda, East Singhbhum-832102 which should reach before as stipulated date and time above.

The eligibility is to be decided strictly based on documents submitted at the time of receipt of tenders. No additional documents are to be allowed to be submitted after receipt of tenders but there is no bar to seek clarification or authentication of submitted documents. However in case of Poor Response, with a view to increase the competition, admission of additional documents to meet the PQ-criteria may be allowed subject to the condition that

- a) "Poor response" implies when less than three bids are found suitable on the basis of submitted eligible documents as per NIT.
- b) The additional document should not be issued subsequent to last date of receipt of tender as m entioned in the NIT.
- C) The bidder submitting additional documents has submitted EMD and tender cost as prescribed in NIT.

The opportunity of submission of additional documents will be given to all the bidders. The successful te nderer shall have to comply with provisions of contract Labour (Regulation & Abolition) Act, 1970 and E PF & MP Act, 1952 and rules framed thereunder. - 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
