- 1. - 5. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. - 2. Tenderers shall submit an undertaking letter that they have not blacklisted/ debarre d/suspended etc. from any of the public sector undertakings/ PS enterprises..
- 3. They are also advised to physically visit the site if required to understand site working conditions, nature & mode of operation of jobs prior to quote for the same.

2.2 **PENALTY:**

In case of non-availability of the vehicle due to break down, absenteeism or for an y reason attributable to the contractor, a penalty at the rate inclusive of variable cost for non-availability period shall be imposed if suitable substitute is not provi ded in time as per given below formula. If the contractor is continuing the non-av ailability of vehicle, the penalty will be applicable on cumulative basis up to maxi mum limit of @ 2% of the work order total value (Subjected to no other additional penalties).

Additional PENALTIES Imposition apart from non-availability: Additional Penalties will be applicable as per the recommendation of Engineer-in-charge against party from RA Bills as per applicability. In case they have caused loss to other party, lo ss can be financial as well as reputational. These losses may occur due to breach of contract/ agreement, faulty services, non/ delayed payment to the Service Prov ider for the services availed. Amount of penalties/ fine shall be settled/ recovered during next payments/ final settlements of the service provider. Additional Penalties and fine are detailed below. However the total amount towards penalties including non-availab ility of vehicle & Additional Penalties should not exceed @ 2% of the work order total value
