#### 1. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

#### 3. Generic

## **SCOPE OF WORK**

Brief description of the work is as given below:

Non-Destructive test of vital winder components (Evaluation of present condition of the existing winding system) of 400KW double drum winder in Turamdih Mines to fulfil the requirement of Reg. 89 (2) read with DG circular 10/1982 of MMR 1961.

Following are the list of the components to be tested :

- 1. Drum Shaft: 01 Nos.
- 2. Gearbox Shaft: 03 Nos.
- 3. Gears of winder gear box: 02 Set
- 4. Brake post (Caliper type) Surface areas near holes and weld joints at the top & bottom ends: 04nos.
- 5. Complete assembly of horizontal tie rod, which include fork, eye, pin etc.: 02 Sets.
- 6. Complete assembly of vertical tie rod, which include fork, eye, pin etc.: 02 Sets.
- 7. Complete assembly of counter weight (Dead weight holding) rod with pin & nut: 02 Set.

- 9. Sheave wheel pulley shaft: 03 nos.
- 10. Cage / Skip suspension Gear: 02 sets
- 11. Skip: 02 Nos.
- 12. Bottom pins of brake posts: 02 Nos.
- 13. Thrustor brake assembly Etc.

# Disclaimer
