SCOPE OF WORK

Title of work: "Deployment of manpower for Jungle cutting, surface dressing and drain cleaning work at Narwapahar Township for the year **2024-2026** (Two years)"

Location of work: UCIL, Narwapahar Township, East Singhbhum, Jharkhand, 832111

Scope:

- 1) Deployment of 08 nos. Un-skilled manpower for jungle cutting/clearing including uprooting of rank vegetation, long grass, bush wood, trees and saplings of girth up to 30 cm measured at a height of 1 mtr. Above ground level and removal of rubbish up to a distance of 50 mtrs. Trimming/Cutting of branches, (Avenue/Long life plants/forest plants), Surface dressing of the ground including removing vegetation and inequality not exceeding 15 cm deep and disposal of rubbish, load up to 50 mtrs and lift up to 1.5 mtrs cleaning and removal of liquid mud loose soil, silt, slush, garbage, vegetation etc. from existing "open/covered" drains cost of loading unloading and disposal of the same at outside dump area, loading & unloading of flower pots (Departmental tractor will be provided free of cost as and when available) including cost of tools and tackles complete as per instruction of Engineer-in-charge. **Total quantity of work will be for 4880 man days.**

(Rate should be quoted inclusive of minimum wage, insurance, safety equi

ment, Personnel Protective Equipments for all employee, Overhead charges, Medical, profit and other Misc.)

2) Supplying and providing 02 (two) numbers of new working Honda Lawn mowers (thread type) for 400 machine days. The maintenance will be done by the contractor including Lubricant and all complete mechanism. Operation of the machine will be done by above unskilled manpower as and when required with the instruction of Engineer-in-charge. **Total quantity of work will be for 400 machine days.**

3) Providing 03 (three) ltrs. Petrol per machine days for the Honda Lawn mowers for 400 machine days as and when required as per instruction of Engineer-in-charge.

Note:- All tools & tackles required for above work are to be provided by the contractor at their own cost. Bidder should quote rates accordingly. It shall be the property of the contractor. He can take back after the completion of contract. However minimum tool and tackles are required to be provided by the contractor on the day of start of the work whose list mentioned below.

All work for civil item shall be carried out as per latest Indian standard, CPWD / ISI and MOST specification which shall form part of this specification and instruction of the Engineer in Charge in case of conflict or where an aspect of work is not covered by the Indian Standard and specification Engineers instruction shall be strictly followed.

1. Average Annual financial turnover during the last 3(Three) consecutive financial years, ending **31.03.2023** shall be at least 30 %(**Rs.11,86,554.47**) of the estimated cost supported by the audited annual accounts of each year.
2. Bidder shall have successfully executed similar work during last 7(seven) years ending on last date of bid closing date as per any one of following:
 - a) Three (3) similar completed work each costing not less than the amount equal to 40 %(**Rs.15,82072.63**) of the estimated cost or
 - b) Two (2) similar completed works each costing not less than the amount equal to 50%(**Rs.19,77,590.79**) of the estimated cost or
 - c) One (1) similar completed work costing not less than the amount equal to 80% (**Rs.31,64,145.26**) of the estimated cost.

Date of award of all the work order in (a),(b) & (c) must be within 7(seven) years ending on last date of bid closing date.

The corporation may request to the bidder to visit the proposed work site to well acquaint about the site work before filling the rate /submit the tender.

3. ***Bidders must attach Work done certificate mentioned executed amount and date of completion and completion certificate.***
4. **GEOGRAPHIC PRESENCE:** Office registration certificate: Registered Office or at least one of the registered Branch Office of the Bidder shall be located and registered within geographical limits i.e 50 KMs from head quarter of consignee i.e., U.C.I.L Jaduguda. Valid Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.
 - i) Trade License issued by the local authority in the name of the Firm or

- ii) Landline phone number in the name of the Firm or
- iii) Electricity bill for last one year in the name of the Firm or
- iv) GSTIN registration or
- v) Udyam/MSME/Udyog Aadhaar Certificate
- vi) Rent agreement shall not be considered as proof of Address .

5. Similar works means: "Experience contractors have completed the following job successfully for **Civil Maintenance /Labour Supply works for any work/Jungle cutting and drain cleaning work.**

- 6. All related documents should be attached/ uploaded by Bidder should be clear and visible otherwise bid will be rejected.
- 7. Party should be MII class 1 local supplier. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate regarding the percentage of the local content along with their bid, failing which the bid is liable to be rejected.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
